- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the enrolled members thereof; and
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls, and
- WHEREAS, Ethel Louise Baker requested relinquishment of his/her membership from the Three Affiliated Tribes, Membership has been requested with the Rincon San Luiseno Band of Mission Indians, and
- WHEREAS, A copy has been received of application confirmation from the Rincon San Luiseno Band of Mission Indians.
- NOW THEREFORE BE IT RESOLVED, that **Ethel Louise Baker** is hereby relinquished from the official membership roll of the Three Affiliated Tribes.

BE IT FURTHER RESOLVED that the **Rincon San Luiseno Band of Mission Indians**, is to be advised with a copy of this resolution.
