



**RESOLUTION OF THE GOVERNING BODY
OF THE THREE AFFILIATED TRIBES
OF THE FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, "AUTHORITY FOR THE THREE AFFILIATED TRIBES DIVISION OF CHILD SUPPORT ENFORCEMENT (TAT DCSE) TO OBTAIN INFORMATION FROM TAT/MHA DEPARTMENTS FOR THE PURPOSE OF ESTABLISHING AND ENFORCING CHILD SUPPORT ORDERS."

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws under said Act; and

WHEREAS, pursuant to Article III, Section 1 of the Constitution and By Laws of the Three Affiliated Tribes, the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, pursuant to Article VI, Section 5 (1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and

WHEREAS, the children of the Mandan Hidatsa Arikara Nation are its most treasured and vital resource, and it is essential that the Mandan Hidatsa Arikara Nation protect them by ensuring that their parents provide them with the necessary support to achieve their full potential to lead the Mandan Hidatsa Arikara Nation into a strong future; and

WHEREAS, the Mandan Hidatsa Arikara Tribal Business Council has authorized the TAT DCSE to administer the Tribal IV-D Child Support Enforcement Program (Resolution No. 05-36 NH), which necessitates obtaining information from tribal departments on employment status, wages, benefits, Employment and Training services, school enrollment, tribal enrollment, and custody placement among others, to enforce or establish child support orders.

NOW, THEREFORE BE IT RESOLVED, that the Mandan Hidatsa Arikara Tribal Business Council hereby grants the TAT DCSE the authority to obtain information from any subsidiary of the MHA Nation for the purposes of establishing and collecting child support; and

FURTHER, BE IT RESOLVED, that the MHA Tribal Business Council hereby grants the TAT DCSE the authority to obtain information from the Tribal Employment Rights Office on obligor parents involvement and progress in programs as necessary to determine compliance with court orders; and


