



**RESOLUTION OF THE GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled "Approval of the Conditional Relinquishment of Anthony Gerald Roasting Stick Enrollment # 301U-08336 from Membership of the Three Affiliated Tribes"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and

WHEREAS, Anthony Gerald Roasting Stick, an adult, has requested a Conditional Relinquishment of his membership from the Three Affiliated Tribes, and has applied for membership with the Chippewa Cree Tribe of the Rocky Boy Reservation; and

WHEREAS, A copy has been received of application confirmation from the Chippewa Cree Tribe of the Rocky Boy Reservation.

WHEREAS, On November 28, 2011 the Three Affiliated Tribes Tribal Business Council reviewed the Conditional Relinquishment Request of Anthony Gerald Roasting Stick; and

WHEREAS, Anthony Gerald Roasting Stick's Relinquishment from the Three Affiliated Tribes will become final on the day the Chippewa Cree Tribe of the Rocky Boy Reservation accepts Anthony Gerald Roasting Stick as a member of their tribe.

NOW THEREFORE BE IT RESOLVED, by the Tribal Business Council of the Three Affiliated Tribes that Anthony Gerald Roasting Stick is hereby Conditionally Relinquished from the official membership roll of the Three Affiliated Tribes; and

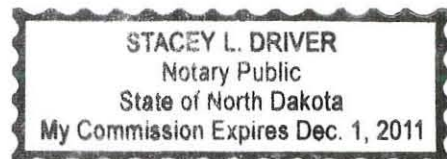


