ITEM NO. 1 CALL TO ORDER

Meeting called to order by Acting Chairman White Bear, at 10:40 A.M.

ITEM NO. 2 ROLL-CALL

Roll called, quorum present - Edmund White Bear acting chairman, Pete Coffey appointed acting secretary.

### ITEM NO. 3 HOUSING REHABILITATION

Discussion: Bertina/Bernard Chase Jr. Application - The application was approved at a General Council Meeting held on October 25, 1984. Several Material Resource Committee members questioned whether this included a deck. After discussion - it was the consensus of the Committee giving authority to the Material Resource Department to build a deck.

Community - Development - Block - Grant - (CDBG) - & - Home - Improvement - (HIP) Budgets

FY-84 CDBG Budget - Arnie read a letter received from the Department of Housing and Urban Development (DHUD) Office. The Tribes will receive \$82,128 for housing rehabilitation and \$20,000 for administering the grant. Arnie stated, that before any funds are drawn down, an environmental status report must be completed.

FY-85 HIP Funds - Arnie explained that the Tribe will receive 75 percent of the total FY-85 Allocation in the amount of \$90,300. The amounts programmed into Home Improvement Category A is \$23,000 and Category B \$49,000. Arnie mentioned that the HIP Budget can be amended at any time during the Fiscal Year. According to Part-100 of HIP Regulations all applications must be prioritized and once they are - we cannot deviate. The BIA would like to know how many homes are left to be renovated, if there are no more, then there will no longer be a need for the HIP Program. The committee will go over any previously prioritized lists at next weeks meeting to make final selections.
