Fox who are over income for propane and Viola  
Schettler for electricity but can apply again

carried.

Weatherization Arnie stated that because of regs  
you can only go into a house once the past few  
months its been a problem finding homes to weatherize.  
Thats why there going into rental units. Now the  
limit is \$560.00. Don Malnourie made a suggestion  
to divide up the money in HIP, CDBG and Weatherization  
in all areas of the reservation, providing all appli-  
cants are on a priority list.

ITEM NO. 6 LAGOON REPAIR

Arnie stated they were awarded \$190,000 for the  
lagoon repair and that in order to work on the  
Dragswolf Village lagoon he needs easements on  
two land owners Donna Morgan and Cami and Jamie
