ITEM NO. 6 HOUSING INVENTORY REPORT

Arnie Guimont explained the Housing Inventory Report. This report was done by Elmer Wells and will be sent to Washington on May 1, 1985. ITEM NO. 7 HOUSING REHAB

Three people from Twin Buttes have water problems they are Freda Chase, Shirley Miller and Ralph Little Owl. Arnie Guimontread a letter from Buddine Stewart, Housing Director, concerning Freda Chase and Shirley Miller that made satisfactory arrangements to pay their house payments. This will make them eligible for housing rehab.

Recommendation - Tabled until next weeks meeting for estimates on all three applicants.

Willard Yellow Bird has water problems with his pump. He brought in an estimate for his pump. Recommendation - Tabled until next weeks meeting. He has to fill out Housing Rehab application to see if he is eligible for assistance.

ITEM NO. 8 IHS CHECK

The Tribe was awarded money to renovate two lagoons: Four Bears and Dragswolf Village. Four Bears is ready to start work on it. Dragswolf Village has easement problems, Legal Attorney Kip Quale and Arnie Guimontare working with Housing Authority to resolve the problem. When money was awarded the Utilities Commission did preliminary work last summer to receive this award from HUD. The money was received last week for these two lagoons. Arnie received a call from HUD, Denver, CO to send check to IHS in Aberdeen. Arnie Guimont asked Edmund White Bear to hand carry the check in the amount of \$179,000 to IHS. IHS will do the engineering, will go to bid, and hire contractor and do the inspection for the two lagoons.

ITEM NO. 9 OTHER REHAB

Arnie Guimont was asked by the committee to check on: Rhoda Mountain, George Lewis, and Glen Perkins housing problems and applications, and have information by next weeks meeting. And get a hold of Connie Howling Wolf and discuss moving her house or try to obtain water.
