ITEM NO. 1 CALL TO ORDER

Chairman Gordon Blake called the meeting to order at 10:15 A.M. He appointed Don Malnourie

as Acting Secretary.

ITEM NO. 2 ROLL CALL

Roll was called by Acting Secretary Don Malnourie,

quorum present.

ITEM NO. 3 MINUTES

June 19, 1985 minutes were read by Acting Secretary Don Malnourie.

Comments: Arnie Guimont mentioned on Motion No. 1 as far as using CDBG monies for force account it is eligible but we will be writing letter to HUD explaining this.

On Item No. 5, Louella Young Bird's electric bill, Arnie Guimont mentioned the check was made and sent to Mckenzie Electric-\$461.63. Norma Staples said according to the LIHEAP plan, we cannot pay a bill when there is no one living there. Norma said there was a letter in Louella's folder stating the program was no longer going to pay her electic bill because she was not living there. Norma said this would be questioned when they do an audit on the program, and the Tribe would be responsible for the payment.

Chairman Gordon Blake explained a family was moving in but they could not move in because Mckenzie Electric would not hook them up to electricity. They had no place to go, they were on their way out of housing authority. They already applied for that house and was approved to get in. They got all there hookups except for electricity and

that was putting hardship on them. And Louella Young Bird was approved previously, however we didn't know the story that she wasn't in there day in orday out, she wasn't in there completely, but in order to relieve the hardship on this other family, we had to approve it and get them in. He suggested we can take it to court and collect from Louella Young Bird.

Motion No. 1 - Moved by Don Malnourie to refer Louella Young Bird's electric bill to court system to be collected, motion seconded by Pete Coffey. Vote: All in favor, motion carried.

Motion No. 2 - Moved by Pete Coffey to approve June $\overline{19}$, $\overline{1985}$ minutes with stipulations and corrections, motion seconded by Ernest Stone. Vote: All in favor, motion carried.

LTEM NO. 4 WEATHERIZATION

Motion No. 3 - Moved by Pete Coffey to approve Renetta Smith for Weatherization, motion seconded by Don Malnourie. Vote: All in favor, motion carried.

ITEM NO. 5 FORCE ACCOUNT CONSTRUCTION

Arnie Guimont explained the force account construction needs a modification on the plan of operation, they need to hire a three man crew, because they are not moving fast enough to finish the projects by September 30, 1985.

Motion No 4 - Moved by Pete Coffey to approve the plan of operation for the second crew for Force Account Construction, motion seconded by Ernest Stone. Vote: All in favor, motion carried.

Motion No. 5 - Moved by Don Malnourie to approve Drew Hopkins salary to \$6.00/hr., motion seconded by Edmund White Bear. Vote: All in favor, motion carried.
