18. INTERIM GRAZING RESOLUTION #00-108-DSB:

Councilman Hale motioned to compromise on an annual rate \$6.00 per animal unit for each grazing unit. The compromise meets the needs of tribal ranchers and the interest of the landowners who are allowing the land to be leased. Seconded by Councilman Gillette.

Discussion: Concerns raised compromise is too low. Independent appraisal is

\$4.80 and B.I.A. suggested rate is \$6.92 on allotted land.

Agreements for tribal ranchers to be included in set rate but not to

set standards for the Bureau.

Vote: 4 Ayes, 3 Nays, 0 Abstentions, 0 Not Voting. Motion carried.

19. 477 OFFICE SPACE/SILVERADO:

Motion by Councilman Marcus Wells Jr. to approve of the use of the Silverado building to the 477 Program. Seconded by Councilman Hale.

Discussion: Concerns were raised for other programs that need office space.

Other vacant locations in New Town to be examined.

Vote: 7 Ayes, 0 Nays, 0 Abstentions, 0 Not Voting. Motion carried.

Motion made by Councilman Gillette to purchase the Zinee Pederson building with an approved appraisal value established. Preference will be given to enrolled member Lois Lockwood for use of building. Seconded by Councilman Bird Bear.

Vote: 7 Ayes, 0 Nays, 0 Abstentions, 0 Not Voting. Motion carried.

20. GAME & FISH RELOCATION:

Motion made to move Game & Fish to a new location by Councilman Marcus Wells Jr. Seconded by Councilman Gillette.

Vote: 7 Ayes, 0 Nays, 0 Abstentions, 0 Not Voting. Motion carried.

21. OPERATION CLEAN UP DAY GRANTS: #00-108-DSB:

Motion made by Councilman Hale to give each district \$1000.00 to establish clean up days and award bikes to children who participate with the most bags of trash. Seconded by Councilman Bird Bear.

Vote: 7 Ayes, 0 Nays, 0 Abstentions, 0 Not Voting. Motion carried.

Motion made by Councilman Hale to adjourn. Seconded by Councilman Gillette.
