Fort Berthold Housing Authority received \$5.2 million from HUD last year and is moving forward and rigorously working to improve services on the reservation. In recent years we have been on eggshells due to HUD not giving funding on a regular time, this year we were 9 months behind on getting our funding but we manage to keep all employees and maintain our services. We are looking to demolish and replace 8 units throughout the reservation when the season allows, completely renovate 4 units, and replacing at least 8 roofs. Renovating the USDA units known as Brook Heights apartments. Our Tax Credit units are in dire need of a new air conditioning and heating system in our Elder complex know as Hidatsa Homes and is a work in progress and completion time is end of January 2019. We receive minimal funding for our Tax Credit, USDA and Title VI due to



vacancies and qualification and are looking to help support these units by funding them to keep them in compliance. Upcoming Housing Assessment & continued program collaboration. To return to the January Meeting

Bighorn Sheep Project to bring in the big horn sheep from Rocky Boy, Montana for a cost of \$1,500 per sheep. The animals have not been on Fort Berthold for 150 years. The State started to reintroduce the sheep in the 1950's. Councilman Mervin Packineau discussed the Antiquities Act and set aside lands for a refuge in each segment for pristine lands. Some of the sheep grow to 300 lbs. and can withstand the winters. It was noted that there is some wolf predation but more mountain lion in the western side of the river. Kristen Mason noted that a 60 mile radius quarantine zone to keep away from domestic sheep. Seeking \$300,000 from the Tribe, and other foundations. It will cost \$4,000 to get them here. There would be no hunting for 7 years to insure the success of the reintroduction of the species. Chairman Mark N. Fox recommended getting Legal involved for an agreement.

A tribal code would be needed and there is a need to manage burial plots and develop cooperation with the churches. Councilman Mervin Packineau & Councilman Fred Fox are going to collaborate on renovation of the Congregational church.


