CALL TO ORDER:

Councilman Cory Spotted Bear called the meeting to order at 11:20AM.

1) New Town - Marc Bluestone, Superintendent Marc gave update. Current Fiscal Year Budget: \$19,153,388.92. Expenses to Date this Fiscal Year: \$18,402,582.14 with 96.04% of the budget expended. Student Population (K-12): 968 students (854 or 88% American Indian students). Ethnic Diversity of NTPSD#1: Teaching Staff (89) [52 Non-Indian (58%), 15 American Indian (17%), 22 Other Minority (25%)]; Administrative Staff (8)[4 Non-Indian (50%), 4 American Indian (50%)]. Hiring Staff for 2019-2020 School Year (Assistant Elementary School Principal; High School Mathematics; 1st Grade Teacher; 5th Grade Teacher). Implementation of ICU (before school, lunch, and afterschool mandatory homework assistance began; automated phone calls or emails to parents/guardians whenever their child does not tum in homework). Community in Schools Project Implementation (Positions Advertised; Collaboration with MHA Nation on Coordinator Position; On Site Training Visits from National CIS Office on April 23rd-24th) Continued. Total Number of Students: 275. Total number of American Indian Students: 205 (74.54%). Parshall Elementary- 89.99% year to date- 87.2% for last four weeks. Parshall High School - 90.2% year to date - 89.5% for last four weeks. District- 92.8% year to date- 90.5% for last four weeks. AdvancEd/Strategic Planning: Goal before next school year is to have a new mission and vision statement. Safety/Wellness: Catlin, by TAT Orders, is now needing to cover all non-emergency calls that come through dispatch. Indian Education Report: We have \$44,000 to spend. Curriculum: Discussion of possible new electives. The High School is looking at Achieve 3000 & Language Live.

C. Head Start Program – Kelly Bradfield, Director

No action items. Have 7 employees graduating with their Bachelors this month. Need a mental health person for head start. Have to license or certified. Will most likely have to get a contract and work with someone out of Minot. Put in for a \$2.5 million Early Childhood Grant. At 70% expenditure on the fiscal year budget. Head Start is in need of 2 vehicles, will have to add it into the budget. There is a measles outbreak in the South, want to make sure our children are all immunized. Councilwoman Monica Mayer would like to see it in a report.

D. Infant and Toddler Program – Kim Dickins, Director

Kim gave report. They continue to promote the program. Picked up 8 new children this month. Would like to update the programs vehicles. Want to trade in 2 department mobile homes for a newer one. Requested to get on Facebook and promote the Program. Send budget to Councilman Cory Spotted Bear.

Motion: Councilwoman Monica Mayer moved to take the existing budget to the budget meeting, to upgrade used RV's. Councilman Mervin Packineau seconded the motion. Vote: 3-0-0. Motion carried.

E. Nueta Hidatsa Sahnish College (NHSC) – Twyla Baker, PhD,, President Submitted written report that included financials, student statistics & program data. Start running numbers now that the school year is done. Enrollment has dropped. Requesting \$100,000 to assist funding Athletics for the FY2020 year. Total Athletics budget is \$ 202,833.00. Total Students to Register Spr. 2018 (non-dual credit): 141students(Number of Students Withdrawn to Date: 95 students). 58% of those who enrolled are Three Affiliated Tribes.

C. TAT Proposal for Education Funding – Angelita Felix

First Native American woman in ND to earn a Doctorate in Education with 40 years of experience in Education. Wrote contracts for the Reservation. Been in contact with Dr. Ruth Hall. Would like to see what Martha Hunter has for data because of the resolution. Would be nice to get her approval. Another tribe funds their students unmet needs. Councilman Cory Spotted Bear will read the information and set up a meeting to discuss what the possibility is implementing something like this. The second part is incentives, such as some getting money for completing certain points of schooling. Councilwoman Monica Mayer states they are working on sessions to assist

with programs. Councilwoman Monica Mayer would like Angelita to consider being a consultant with the tribe. Angelita would like to get assistance with gas, but would not want to be a contract worker, she would rather contribute and give back to the Tribe.

D. Education Assistance – Dillion Bercier

Brought in statement showing enrollment. Offices will do a 4 way match to cover \$1,072. Each office will help with \$268.00 each.

E. Pipeline to Law Training Request – Robert Hunter Sr.

Looking for financial assistance to attend *Pipeline to Law*. Budget is \$4,322. It is a weeklong training. Forward to June 13th TBC. The training is late June.

Motion: Councilwoman Monica Mayer moved to forward request to TBC. Councilman Mervin Packineau seconded the motion. Vote: 3-0-0. Motion carried.
