RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes have continuously maintained an attorney contract with the Washington, D.C. law firm of Hobbs, Straus, Dean & Wilder since January 1, 1978, which contract is designated by the number AOOC14201145; and
- WHEREAS, The initial two (2)-year term of said attorney contract extended from January 1, 1978 through December 31, 1979, and the contract term has been extended by the parties every two years thereafter; and
- WHEREAS, The most recent two (2)-year extension of said contract was unanimously approved by the previous Tribal Business Council, at its December 14, 1989 meeting exclusively by formal motion, without a resolution having been drafted and executed; and
- WHEREAS, It is the desire of the current Tribal Business Council to ratify such approval action taken by the previous Council to extend the attorney contract at issue from January 1, 1990 through December 31, 1991, and to submit the approved extension to the Bureau of Indian Affairs for formal and expedited review and approval;
- NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes, pursuant to its authority under Article VI, Section 3(a) of the Tribal Constitution hereby formally ratifies the motion unanimously approved by the previous Tribal Business Council at its December 14, 1989 meeting, to extend Attorney Contract No. AOOC14201145, for an additional term of two (2)years, to extend from January 1, 1990 through December 31, 1991.
