- WHEREAS, It is within the Tribal Council's authority to set the rate of pay for Councilmen; and
- WHEREAS, The Rate of Pay for a GS-12 is \$37,294.00 and GS-11 is \$31,116.00; and
- NOW, THEREFORE, BE IT RESOLVED, that the Rate of Pay for the Tribal Chairman is \$37,294.00 and for all other Councilmen is \$31,116.00 and this Rate of Pay is retroactive to January 1, 1991; and

BE, IT FURTHER RESOLVED, that this constitutes and approves Amendment #1 to the Tribal Budget.
