Mandan, Hidatsa, and Arikara Nation responds to Department of Interior opinion on Missouri River mineral rights

New Town, N.D. - On Tuesday May 26, 2020, the Trump administration, acting on a request from the state of North Dakota, illegally confiscated the Mandan, Hidatsa, and Arikara (MHA) Nation's minerals beneath the Missouri river on the Fort Berthold Reservation. Without consulting the MHA Nation, the Department issued a false M-Opinion which overturned three prior decisions of the Department, including two prior M-Opinions recognizing the MHA Nation's title to the riverbed, one of which has stood for 84 years. In doing so, the Department violated the United States obligations under its 1825 treaties with the MHA Nation as well as its fiduciary duty to protect the MHA Nation and its property rights. The Department also failed to consult with the MHA Nation before the taking and did not wait for the MHA Nation's historical report as previously agreed. The statement below from MHA Nation Chairman Mark Fox can be quoted in-full or in-part.

The MHA Nation demands that the Department of Interior uphold its duty as our Trustee and protect the MHA Nation's Missouri River property rights. We demand the DOI immediately withdraw its M-Opinion and abide by the longstanding precedent beginning with its 1936 decision that affirmed the MHA Nation's rights to the riverbed.

The Missouri River has been central to our people's self-sufficient way of life since time immemorial. Our historic holistic relationship with the River is well known and documented—this includes the riverbed minerals and bottomlands we have utilized for our spiritual well-being, our food, agriculture, and trade economy for thousands of years.

Mike Lawson, a nationally renowned Missouri River historian, thoroughly investigated the MHA Nation's historical usage of the Missouri River and found time again our deep economic, cultural, and spiritual usage and dependency on the Missouri Riverbed.

Lawson's extensive research identified an expanded number of legal and historical events that support the riverbed ownership of the MHA Nation across nearly two centuries. Yet, the DOI did not wait for the report as promised before issuing their misguided M-Opinion.

The legal and historical precedent is clear: MHA Nation owns the rights under the riverbed within the boundaries of the Fort Berthold Reservation. The Department's politically motivated action is nothing more than an illegal taking.

The Breath of God

As with Adam, made out of the dust of the ground, the Breath of God or Spirit had to be breathed into him before he came to life. This day is traditionally called Pentecost, which is the last day of the Easter Season or the fiftieth day after Easter Sunday. This year the Church celebrated Pentecost amid a pandemic that has greatly affected humanity around the world. For America, in addition to the psychological, physical, emotional and economic inflictions caused by Covid-19 deaths and stay-at-home lockdowns, Americans are also wrestling with moral issues surrounding the death of George Floyd and those who incite immoral behavior. forward through this pandemic,

others are getting comfortable. The Chairman of the MHA Nation spoke about the case numbers in North Dakota as well as the United States. He is a strong advocate of PPE and testing, as he wants to protect the people of the MHA Nation. "We continue to push to promote the use of PPE. The numbers continue to grow each day, as we expected," Fox explained. These spikes will continue to occur." He spoke about the importance of following the mitigation measures put in place, and that the pandemic is not over. He encouraged people to wear their masks, wash their hands, and be cautious in handling items along with continuing to social distance. Currently within the MHA Nation, there has been around 1,300 COVID-19 tests administered. Testing occurs Monday through Friday, with about an average of 30 people tested per day. Fox said, "We want to keep pushing hard towards testing 2,000 people by at least the 4th of July. Fort Berthold has about 37 confirmed cases, and we are very elated we could slow the spread on the reservation. That is a result of all of our people, communities, frontline workers, and COVID-19 Task Force contributing their time and efforts to do what is nearly miraculous. We have stayed in the mid-30s for more than 4-5 weeks, with only a couple new cases. Although we do need to test more, we have slowed the spread." The Search For A Coronavirus Vaccine and Why Masks Are Still Important

The search for a coronavirus vaccine is a worldwide effort. The approach is hi-tech and involves nations around the world but vaccination was not always the result of laboratories and legions of scientists. In fact it may surprise you to know that the idea of inoculation\ vaccination has been around for over 500 years.

A BRIEF HISTORY OF VACCINATION

The earliest written evidence of the idea of receiving a vaccine to inoculate someone against the virus comes from China and a book dated from 1549 called On Measles and Smallpox. (This raises certain questions for MHA Nation historians because while smallpox ravaged our population there was a method to inoculate people against it and had been for over a hundred and fifty years. But that is another topic!) This ancient Chinese practice was not exactly what we would think of as a vaccination but fluid from a smallpox infected person was purposefully given to someone else to give them immunity. The natural question is why didn't the second person infected get as sick as the first? This has to do with a scientific principle that many believe may apply to the Coronavirus and explain why some people get really sick and some people don't. This is called the "dose-response curve" .

THE DOSE-RESPONSE CURVE

The dose-response curve is actually a pretty straightforward idea. Viruses are transferred via little individual particles called "virions". Each virion is a little factory and produces more of a virus. If you encounter a lot of virions they all start producing and can overwhelm your immune system. If you encounter a small number that gives your immune system time to ramp up and fight it before too much of the virus is produced. So, some people who get a big dose of virus to begin with get sicker and some people who may not have received as big a dose may not get as sick. There are a lot of other factors that may be involved in the severity of illness from Coronavirus but the dose response curve is one that's being heavily researched now.

VACCINATION

The dose-response curve has to do with a living active virus. This differs from how vaccination works because in a vaccination, the virions are disabled before they are injected. Basically the virus factory is shut down which gives the immune system plenty of time to recognize it and mount a defense if it encounters a living virus.

WHY DOES IT TAKE SO LONG TO DEVELOP A VACCINE?

In reality, vaccines don't take very long to be created. Where the greatest time is involved is in testing them to make sure that they are both safe and effective. The standard for safety of a vaccine is extraordinarly high. This is how it should be for something that may be given to 350 million people. 99% is not good enough. It would also be almost as bad to give people a vaccine that didn't work. This would give them a false sense of security that could lead to the virus actually being spread farther.

SO WHAT'S HAPPENING NOW?


Right now China is ahead in the race to create a vaccine. This makes sense because they've had longer to work on it. Currently the US has three human trials in the works. These trials usually take 12 to 18 months even if they are fast-tracked. Again this is to make sure that the vaccine is both safe and effective and so it can only be rushed so much without endangering people.


WHAT DO WE DO UNTIL THERE IS A VACCINE?

Until there is a vaccine the CDC is recommending MASKS FOR EVERYONE. You may have heard it before but if everyone wore a mask not as many virions would be spread and an estimated 85% of infections could be avoided. Also to go back to the dose-response curve, if the virus in your sneezes and coughs is caught mostly in your mask that means even if you infect someone you may not give them as bad a case as you would otherwise. So until a vaccine is available please wear a mask. It does make a difference.

Masks reduce airborne transmission

Infectious aerosol particles can be released during breathing and speaking by asymptomatic infected individuals. No masking maximizes exposure, whereas universal masking results in the least exposure.


