

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled," Order of Business – November, 2004 pursuant to the Constitution and By-laws of the Fort Berthold Reservation."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article III, Section 5 of the By-laws of the Three affiliated Tribes of the Fort Berthold Reservation states that at the first meeting of the newly elected Tribal Business Council, it shall establish by Resolution a Regular Order of Business; and
- WHEREAS, the Tribal Business Council is formally reorganizing upon completion of the November 2, 2004 Tribal Election duly held and certified on November 5, 2004
- WHEREAS, the Tribal Business Council feels that it is critical that the membership be assured that its governing body is committed to adherence to the Constitution and By-laws of the Fort Berthold Reservation and so as an Order of Business;

## NOW THEREFORE BE IT RESOLVED, BE IT FINALLY RESOLVED, that the Tribal Business Council hereby confirms the following:

- 1) Regular Meetings shall be the second Thursday of each month and shall be called to order at 10:00 a.m., and shall be adjourned at 5:00p.m., and if needed, shall reconvene at the next scheduled meeting.
- 2. The Minutes shall be duly approved and signed at the next Regular Meeting; and all Tribal Business Council Reports shall be given,
- 3. All adopted Resolutions shall be fully attempted to be signed and approved or as soon as they are prepared, with amendments and approved by the following day, and
- 4. The Tribal Secretary of the Tribal Business Council shall honor Tribal Elders and Youth and prioritize their respective requests at the beginning of the agenda of a Regular Meeting or to convene a Special Meeting.

5. In accordance with the Constitution and By-laws, that the Tribal Business Council convene Special Meetings to take up only emergency issues or items that cannot be deferred until the next Regular Meeting.

## CERTIFICATION
