



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled: "Approval of Home Site Leases and Utility Corridors for Home Sites"

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws pursuant to said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes (or "Tribes") generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and

WHEREAS, Article VI, Section 5 (l) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies; and

WHEREAS, The Three Affiliated Tribes has authority to approve of Home Sites and Utility Corridors on Tribal land; and

WHEREAS, The Three Affiliated Tribes finds it beneficial to provide for use of Tribal lands for Home Site Leases and Utility Corridor Easements.

NOW, THEREFORE, BE IT RESOLVED that the Tribal Business Council of the Three Affiliated Tribes approves the Home Sites and Utility Corridors listed below:

Northeast Segment - Home Sites:

- **Winona Dobbs-Goodleft, a TAT Enrolled Member,** 2.5-acre home site on Allotment 338A, NE $\frac{1}{4}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 36, T. 150 N., R. 90 W., Mclean County, 5TH PM of ND. Mrs. Goodleft owns undivided 22.22% interest in this allotment and the Tribes' share of said property, is an undivided 55.55% interest.
- **Haley K. Wolf, a TAT Enrolled Member,** 2.5-acre home site on Allotment T317AG, NE $\frac{1}{4}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 4, T. 149 N., R. 90 W., Mclean County, 5TH PM of ND
- **Wayne Simpson, a TAT Enrolled Member,** a home site on Tribal City Lot 580054000, Lot 8, Block 4, Phinney's Addition, City of Parshall, Section 25, T. 152 N., R. 90 W., Mountrail County, 5TH PM of ND



East Segment - Home Sites:

- **Llore Dawn Dickens, a TAT Enrolled Member**, 2.5-acre home site on Allotment 139A, within the SW $\frac{1}{4}$, Section 32, T. 148 N., R. 88 W., with an undivided .1357441225 Tribal interest, McLean County, 5TH PM of ND

North Segment - Home Sites:

- **Thomas Jay Plenty Chief, Sr., a TAT Enrolled Member**, 2.5-acre home site on Allotment T439A-B, NE $\frac{1}{4}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 10, T. 150 N., R. 93 W., Mountrail County, 5TH PM of ND
- **Wesley Scott Wilson, Sr., a TAT Enrolled Member**, 2.5-acre home site on Tribal Fee Tract 450013837, Lot 34, Block 1, Van Hook Subdivision, Section 29, T. 152 N., R. 91 W., Mountrail County, 5TH PM of ND
- **Debra Two Crow, a TAT Enrolled Member**, 2.5-acre home site on Tribal Fee Tract 450013827, Lot 24, Block 1, Van Hook Subdivision, Section 29, T. 152 N., R. 91 W., Mountrail County, 5TH PM of ND

Utility Corridor:

1. Approve an easement for Water Service Line with the home owner in the above-mentioned Tribally owned land in each segment. The easement will run a service line to a home site being built in and across all Tribal owned lands.
2. Approve an easement for the local electric cooperative, which will be providing an Electrical Service Line in the above-mentioned Tribally owned land in each segment. The easement will run a service line to a home site being built in and across all Tribal owned lands.
3. Approve an easement for Telephone/Internet service with the Telephone Cooperative for providing a Service Line in the above-mentioned Tribally owned land in each segment, in and across all Tribal owned lands.
4. Approve an easement for an access road with the Roads Department, to provide an access road in the above-mentioned Tribally owned land in each segment. The easement will run a road to the home site being built in and across all Tribal owned lands; and

BE IT FINALLY RESOLVED that any of the Tribal Business Council Executive Officers is authorized to sign the aforementioned applicable lease documents on behalf of the Tribes for the transactions above.
