Motion No. 1 - Treasurer Goodiron moved, seconded by Secretary Mason for approval of the September 15-16, 1983 Regular Meeting mintues. Eight (8) in favor, motion carried.

ITEM 4 LAND EXCHANGE FOR PAT AND MABEL FREDERICKS

Motion No. 2 - Councilman White moved, seconded by Councilman Coffey for approval of a land exchange with Pat and Mabel Fredericks of 27.52 acres and 40 acres of tribal land, and to waive the \$23.70 cash difference that was in the Fredericks' favor. Seven (7) in favor, motion carried.

Councilman Bird Bear left to attend a Housing Authority meeting.

Motion No. 3 - Secretary Mason moved, seconded by Treasurer Goodiron to put the purchase of the remaining 10 acres of Mabel Fredericks, Allotment 1946, on the priority list in the FY1984 Land Purchase budget. Seven (7) in favor, motion carried.

ITEM 5 TRIBAL COUNCIL T/2 BUDGET

Discussion followed on the Council's T/2 budget and docket monies. The Council requested Treasurer Goodiron to check with Ray Cross on who would be entitled to interest earned from docket funds while it is with the Tribes.

Motion No. 4 - Councilman White moved, seconded by Councilman Malnourie for approval of the proposed 1984 Tribal Council Budget. Seven (7) in favor, motion carried.

BUSINESS DEVELOPMENT FUND ITEM 7

Discussion followed on the Business Development Fund. Mike Cross said a plan of operation had to be developed and approved by Aberdeen before funds can be used. The Council decided to place this matter on the agenda for the next full Council meeting.

FARM AND GRAZING LEASES HELD AT THE BUREAU ITEM 8

Debbie Danks reported there were farm and grazing leases paid in but not paid out to the Tribes at the Bureau in the amount of \$118,915.77. This amount did not include money to be paid out to individual landowners. Mr. Brockie was present at the meeting and stated he would have all accounts cleared as soon as possible and explanation provided, and monies that could be transferred to the Tribes, will be.

Martha Lone Bear was present to find out about status of Janis Lone Bear's lease for Allotments 583A/584A. She has been leasing out her The Bureau, this year, leased it out to somebody land herself. else without her consent. and she had already leased it out, so she is requesting to have the Bureau cancell the lease. Mr. Brockie told her the lease will be cancelled. The Council expressed concern that Titus Marks could not handle his job at the Bureau. The Council requested Mr. Brockie to be at the Regular Meeting to go over problems and set up goal and objectives to be done and to set a time limit for them., on October 20, 1983.


PAYMENT TO HOBBS, STRAUS, DEAN & WILDER ITEM 9

Motion No. 13 - Secretary Mason moved, seconded by Councilman White to table resolution regarding the abolishment of Mental Health/Social Aide Position at IHS and fund ^a nutritionist position instead, until more information is received. Seven (7) in favor, motion carried.

Discussion followed on Council travel, and changes were made in the resolution presented by Treasurer Goodiron.
