ITEM 6 LEASE OF TRIBAL LAND - ALLOTMENTS 68A & 100A

Mr. Ambrose Hosie, Sr. and Ambrose Hosie, Jr. were present at meeting regarding the lease of Allotments 68A and 100A. They said they had leases approved for the two tracts of land by the Tribal Council and BIA as of March 21, 1984, and they have already done work on the tracts by putting in fertilizer and working the ground. Now, they received a letter saying they were going to cancell their lease on 68A. They said Greta White Calfe did not come over and ask them if they were leasing the tracts. Action to be taken at end of meeting.

ITEM 7 POUCH POINT BAY - ELECTRIC LINE

The resolution in which the Tribe approves the expenditure of \$1,644 from the Business Development Fund to cover remaining balance necessary for the construction of a electrical line into Pouch Point Bay was tabled, to be taken up at the next full Council meeting.

ITEM 8 RAY CROSS - LEGAL DEPARTMENT

Motion No. 4 - Marie Wells moved, seconded by Donald Malnourie to authorize the Legal Department to continue working on the matter of the electricity bill for the Four Bears Motor Lodge with McKenzie Electric, and to have it resolved by the end of June, 1984. Ten (10) in favor, motion carried.

Motion No. 5 - Dennis Huber moved, seconded by Gerald White for approval of resolution regarding treaty purposes for water negotiations with the State, and authorizes the treaty purposes to be transmitted to ND State Water Commission, with No. (6) added: Such other future uses as the Tribal Business Council may specify. Roll call vote: Dennis Huber, yes; Roy Bird Bear, yes; Gerald White, yes; Ernest Stone, yes; Pete Coffey, yes; Don Malnourie, yes; Tillie Walker, abstained; Marie Wells, abstained; Matt Mason, no.
