Motion No. 2 - Gerald White moved, seconded by Marie Wells, to approve the minutes of the Credit Committee, June 19, 1984; the Human Resources Committee of June 22, 1984, June 26, 1984, June 28, 1984, July 2, 1984, July 11, 1984, July 11, 1984, (Special); the Natural Resources Committee of June 25, 1984; and the Material Resources Committee of June 27, 1984. VOTE: Six (6) in favor, two (2) opposed, one (1) abstaining, motion carried.

Motion No. 6 - Tillie Walker moved, seconded by Marie Wells, to approve the resolution authorizing use of \$19,000 from the Revenue Sharing carry-over monies for the KMHA Radio Station, for operating expenses, with the remaining amount of the Revenue Sharing monies, \$713.69, to go for repair of the road grader. Motion No. 7 - Matthew Mason moved, seconded by Pete Coffey, to approve the resolution authorizing the continuation of Indian Health Service Master Contract, which is requesting \$163,695 for the CHR Program, \$72,062 for the Alcoholism Program, \$78,953 for the Physician Extender Program, and \$13,977 for the Janitorial Program, with a total budget of \$328,687, with indirect cost included. VOTE: All in favor, motion carried. (Reso. 84-186-S)

Motion No. 9 - Dennis Huber moved, seconded by Roy Bird Bear, to approve the resolution directing the Legal Department and the Natural Resources Department to prepare a proposed comprehensive Tribal land use plan. Motion No. 10 - Ernest Stone moved, seconded by Roy Bird Bear, to approve the resolution appointing Dennis Huber as Treasurer of the Tribal Business Council, and accepting Paul Good Iron's resignation as Treasurer, effective 5:00 p.m., July 20, 1984. Motion No. 19 - Gerald White moved, seconded by Roy Bird Bear, to approve the resolution authorizing that the agreement between the Three Affiliated Tribes and Dornbusch & Co. be extended to September 30, 1984, and that Alyce Spotted Bear, Tribal Chairman, be authorized to sign this agreement. VOTE: Five (5) in favor, one (1) opposed, three (3) abstaining, motion carried. (Reso. 84-196-S)

Motion No. 20 - Matthew Mason moved, seconded by Tillie Walker, to change Page 6, Part II, Section 1 of the Election Ordinance to delete the following language, "who has registered in accordance with Part III of this Ordinance or who has met the requirements of Part VII of this Ordinance...". VOTE: All in favor, motion carried.

VOTE: Six (6) in favor, three (3) opposed, one (1) abstaining, motion carried.

Motion No. 22 - Tillie Walker moved, seconded by Gerald White, that a re-vote be taken on Motion 21, since there was a misunderstanding of the motion. VOTE: Seven (7) in favor, two (2) opposed, one not voting, motion carried.

Motion No. 23 - Dennis Huber moved, seconded by Gerald White, to amend Page 6, Part II, Section 2(c) of the Election Ordinance to read as follows: "He has not been found guilty by a court of competent jurisdiction of a felony within the last five years next preceding the date of the election." FINAL VOTE: Five (5)6 in favor, three (2) opposed, two (2) abstaining, motion carried.

It was at this point that the number voting was reduced to nine (9) members, but it was not noted by the Recording Secretary as to which member left the meeting.

Motion No. 24 - Gerald White moved, seconded by Pete Coffey, to amend Page 6, Part II, Section 2(d), to read, "has a discharge other than 'Honorable' from the Armed Services...". VOTE: All in favor, motion carried.

Motion No. 25 - Marie Wells moved, seconded by Gerald White, that Page 6, Part II, Section 2(c) of the Election Ordinance shall include the following categories: all Housing Authority debts in which candidate is delinquent, all leases entered into with the Tribe, court fines and costs, loans, property owned by the Tribe, outstanding travel expenses, and all other delinquent amounts owed to the Three Affiliated Tribes. VOTE: All in favor, motion carried.

Motion No. 26 - Gerald White moved, seconded by Ernest Stone, that the date upon which all financial delinquencies must by satisfied, will be no later than 5:00 p.m. on the date when the Election Board must rule on the challenge to the individual's candidacy. Item No. 22 ELECTION ORDINANCE AMENDMENTS

Motion No. 27 - Dennis Huber moved, seconded by Ernest Stone, to amend Page 6, Part II, Section 2(f) to read as follows: "If the Tribal employee wishes to run for membership on the Council in an election year, the Tribal employee should inform the Personnel Department and their respective Committee, and submit his/her resignation in writing to them, upon filing of his/her candidacy for Tribal office. If the Tribal employee is not successful in his/her bid for Tribal office, he/she shall be re-established in his/her former position with the Tribe." VOTE: Seven (7) in favor, one (1) opposed, one (1) not voting, motion carried.

Motion No. 28 - Dennis Huber moved, seconded by Marie Wells, to create Section 2(g) of Page 6, Part II, of the Election Ordinance, to read as follows: "Neither a consultant of the Three Affiliated Tribes, nor an incumbent of the Tribal Business Council, is deemed a Tribal employee for the purposes of Page 6, Part II, Section 2(f), and this amendment is hereby added to the Election Ordinance as Section 2(g). VOTE: All in favor, motion carried.

#### Item No. 23 WHITE SHIELD SCHOOL DISTRICT

Motion No. 29 - Gerald White moved, seconded by Marie Wells, to approve the resolution recognizing the White Shield School Board's right to contract with the Bureau of Indian Affairs's Aberdeen Area Office (under BIA's Chapter I) and Special Education 94-142, for services rendered for 84-85 school year. Motion No. 41 - Gerald White moved, Ernest Stone seconded, to approve the formal entry of the Three Affiliated Tribes into an agreement between the State of North Dakota and the Tribe, for the operation and maintainence of the Good Bear Bay Recreational Site, and also authorizing Alyce Spotted Bear to execute said agreement. VOTE: Five (5) in favor, four (4) opposed, one (1) abstaining, motion carried. (Reso. 84-204-S) Tribal Business Council Regular Meeting July 19, 1984 Page nine

Motion No. 42 - Tillie Walker moved, seconded by Pete Coffey, that for the purposes of Page 6, Part II, Section 2 (f), the position of Chief Judge be included as not being considered a Tribal employee. VOTE: Six (6) in favor, one (1) opposed, one (1) not voting, motion carried.

Motion No. 43 - Tillie Walker moved, seconded by Donald Malnourie, that Page 7, Part II, Section 3(a), whereby the filing fee for candidates for Tribal Office is set at \$25.00, will remain the same. VOTE: Eight (8) in favor, one (1) opposed, one (1) abstaining, motion carried.

Motion No. 44 - Gerald White moved, seconded by Matthew Mason, that Page 7, Part II, Section 3(a), whereby the time period for filing for Tribal office is set at 40 days, will be extended from 40 days to 50 days previous to the Election. VOTE: Nine (9) in favor, one (1) abstaining, motion carried.

Motion No. 45 - Paul Good Iron moved, seconded by Marie Wells, that Page 8, Part IV, Section 1(a) of the Election Ordinance have the following inclusions: "husband, wife, son, daughter, son-in-law, daughter-in-law, and any step-, foster-, or legally adopted relatives of the aforementioned...", and that these be made a part of this section. VOTE: Eight (8) in favor, two (2) abstaining, motion carried.

Motion No. 46 - Donald Malnourie moved, seconded by Gerald White, to extend Resolution 82-195, which authorizes the use of colored paper (under Page 10, Part IV, Section 2(e) of the Election Ordinance) instead of white paper, for the purpose of printing all Tribal Election ballots. VOTE: Nine (9) in favor, one (1) not voting, motion carried.

Motion No. 47 - Paul Good Iron moved, seconded by Marie Wells, that Page 11, Part IV, Section 3(a) of the Election Ordinance, whereby the time period allocated for the appointment of Segment Election Boards is set at 15 days, will be amended to extend the deadline to 20 days. VOTE: Eight (8) in favor, one (1) not voting, one (1) abstention, motion carried.

Motion No. 48 - Gerald White moved, seconded by Paul Good Iron, to approve the extension of Resolution 82-186, amending the Election Ordinance, and accepting the amendments to the Election Ordinance, and to have the Secretary of the Tribal Business Council delegate the authority and responsibility for delivering the absentee ballots to the place of canvassing, and for making a report on the absentee ballots, and that this amendment be incorporated into the Election Ordinance permanently. Motion No. 50 - Paul Good Iron moved, seconded by Donald Malnourie, to approve the incorporation of Resolution 82-205 into the Election Ordinance, which outlines the procedure for declaring only that portion of the ballot illegal which has been so marked by the voter as to place in doubt his/ her intention. VOTE: Eight (8) in favor, two (2) in favor, motion carried.

Motion No. 51 - Paul Good Iron moved, seconded by Gerald White, to approve the deletion of the following from Page 18, Part VI, Section 3: "the challenged vote does not have to come before the Certification Board...". VOTE: All in favor, motion carried.

Motion No. 52 - Paul Good Iron moved, seconded by Pete Coffey, to approve the amendment which will change the time periods within which the Election Board shall hold a hearing and shall render its written decision on the complaint. VOTE: All in favor, motion carried.

Motion No. 53 - Gerald White moved, seconded by Pete Coffey, that Page 19, Part VII, Section 1(a) of the Election Ordiance shall read as follows: "that the Election Board will mail to the absentee voter his/her absentee ballot on the day immediately following the day when the request is received. VOTE: All in favor, motion carried.

Motion No. 54 - Gerald White moved, seconded by Paul Good Iron, that, pursuant to Page 19, Part VII, Section 1(c) of the Election Ordinance, the Council disapprove the acceptance of hand-delivered absentee ballots to the Election Board, and that for the purpose of interpretation, the word "reached" shall be interpreted as "via mail". VOTE: All in favor, motion carried.

Motion No. 55 - Paul Good Iron moved, seconded by Gerald White, to incorporate Resolution 82-206 into Page 19, Part VIII, Section 1 of the Election Ordinance, which provides that voters who, for business or other matters beyond their control, could not vote in their respective segments on the election date, would be allowed to vote in the segment in which they find themselves, and that these ballots be placed in the "Challenged" envelope, to be checked later. Motion No. 57 - Tillie Walker moved, seconded by Paul Good Iron, to withdraw her previous motion allowing the absentee voter list to be released to candidates running for Tribal office, and to have a post card included in the mailing that goes out to every absentee voter and ask whether or not they would agree to having their name and address released to the candidates and only those people whose cards are returned marked "yes" will have their names and addresses released to the candidates. VOTE: Nine (9) in favor, one (1) abstaining, motion carried.

Motion No. 58 - Paul Good Iron moved, seconded by Donald Malnourie, to approve a new provision in the Election Ordinance, whereby a resident voter who will be unable to vote due to hospitalization or being home-bound due to illness, or who is travelling on business, could vote by signing a sworn affidavit, under oath, and vote via absentee ballot. If a person is hospitalized, they can vote via letter to the Election Board. VOTE: All in favor, motion carried.

Motion No. 59 - Gerald White moved, seconded by Marie Wells, to render the provisions of the Tribal Business Council elections applicable to the election of the office of Chief Judge as well. VOTE: All in favor, motion carried. (Section 2 of Part II)

Marie Wells left the meeting at 4:00, as she had to get to the Clinic to pick up medications before they closed.
