ITEM I JIM DAVIS, DIRECTOR OF INDIAN EDUCATION PROGRAMS

Due to the lack of a quorum, and being that Mr. Davis was pressed for time (he had a meeting scheduled in Bismarck this afternoon), he gave an oral presentation to the Tribal Council members present. Mr. Davis said he was here to give an update on what the Office of Indian Eduation Programs has done within the past year, and what their future plans are. Jim Davis said their office has expanded by working with colleges and universities, and the overall goal is to improve the academic achievements of Indian students. Jim Davis said if any of the schools on the reservation needed technical assistance, they should contact him and he could provide assistance with no charge. The resources he mentioned that were available to him and to us, for the asking, were; Bi-lingual Multi-function Center in Chicago, IL, School Board Training at the Multi-Cultural Training Center in Albuquerque, New Mexico, and the Rapid City Technical Education Center field office in Rapid City. If there were any requests for assistance, services, or instruction, the schools reservation wide, only have to contact Mr. Jim Davis's office in Bismarck.
