He went over the FY-86 Carryover Budget effective period: 10-1-86 to 3-06-87. He needs to do a budget for FY-87 HIP Budget for \$49,000.00. He went over the Water Well List and Applications that are on file. The 1984 CDBG program - 23 projects were completed with this funding. He went over the HIP Selection Criteria on how to select applicants on a point system. He received this on December 11, 1986.

Steve also mentioned that the house they were working on got broken into in New Town. But later they got all the tools back. There was no cops on duty at the time. The only damage was they broke the door the cost is \$94.95. The committee left it up to Steve if he wants to collect from them.
