Hugh Baker made a motion that Delvin Driver serve as a representive for the tribe on the tribal action plan, seconded by Ted Lone Fight III.

ITEM 32 I.H.S. DIRECTOR

There has been numerous complaints on the IHS Director, Ms. Reba Walker. Ed suggested that Council members go out to their districts and get written docemuntations, so the Council could meet with Ms. Walker to see if they could deal with the problem.
