ITEM 1 CALL TO ORDER

Meeting called to order at 11:34 a.m.

ITEM 2 ROLL CALL
Roll called to by Secretary Lone Fight, quorum present.

ITEM 3 LAND SALES
Hugh Baker said a letter of intent will be send over to the BIA for
the land purchases today. Texx Lone Bear said that the Tribe had only
\$70,000.00 to purchase land. \$40,888.05 was already spend to purchase
land. The Tribe has approximately 37,861.00 to purchase land today.

Budget for docket funds was discussed. Hugh moved to recommend Steve Francis to work out docket funds as follows zero out wake fund of \$26,250.00 and put it into Bus. Development and Communications. Steve Francis said there is \$60,000.00 for wake fund only in the bank right now, so even if we zero out the wake fund on docket G we will still have enough money. \$13,148.00 for land purchase was left as a buffer, subject to confirmation with Bureau of Indian Affairs, seconded by Ted Lone Fight III.

Discussion: Hugh said with the \$37,861.00 we will buy \$2,000.00 worth from each tract.
