Moved to approve by Hugh Baker, seconded by Ted Lone Fight III. (Jim Mossett joined the meeting at 11:09 a.m.)

Discussion: Ed Lone Fight said Mandaree and Twin Buttes water systems can be rehabilitated, since they already have water pumped in form the lake.
