

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution entitled, "Authorizing Right-of-Way Use Agreement with North Dakota Department of Transportation for the Purpose of Maintaining a Sign within the North Rightof-Way of Highway 23."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, also known as the Mandan, Hidatsa, and Arikara Nation ("Tribes" or "MHA Nation"), the Tribal Business Council is the governing body of the Tribes; and
- **WHEREAS,** The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribe and of the enrolled members thereof; and
- WHEREAS, Pursuant to Article VI, Section 5(d) of said Constitution, the Tribal Business Council has the power to negotiate with Federal, State, and local governments; and
- WHEREAS, Article VI, Section 5(j) of the Constitution provides that the Tribal Business Council has the authority to protect and preserve the property of the Tribes; and
- WHEREAS, The Four Bears Segment has proposed to have an Electronic Sign (or "Sign") erected within the north right of way of State Highway 23, said device to be located approximately 875 feet east from RP 45.000, in the northwest quadrant of the intersection of Highway 23 and Sakakawea Street, for the purposes of promoting community events and any other such related public purpose; and
- WHEREAS, The Tribal Business Council finds it appropriate to enter into a Right-of-Use Agreement with the North Dakota Department of Transportation for the purposes of erecting and maintaining a Sign at the aforementioned location for the aforementioned purposes.
- NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby approves and authorizes a Right-of-Way Use Agreement, Contract #70191451, with the North Dakota Department of Transportation for the purposes of erecting and maintaining an Electronic Sign within the north right of way of State Highway 23, said device to be located approximately 875 feet east



from RP 45.000, in the northwest quadrant of the intersection of Highway 23 and Sakakawea Street, such Sign to be used for the promoting of community events and any other such related public purposes that fall within the meaning of the Agreement; and

BE IT FINALLY RESOLVED, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.
