

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- A Resolution Entitled: "Approval of Proposal for Pre-Design by Nelson-Tremain Partnership, LLP for the Diabetes Education Center Construction Project"
- WHEREAS, The Mandan, Hidatsa, and Arikara Nation | Three Affiliated Tribes ("Nation" or "Tribes") having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and bylaws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Three Affiliated Tribes' Tribal Business Council to engage in activity on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5(l) of the Three Affiliated Tribes Constitution provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council; and
- WHEREAS, Article VI, Section 5(c) of the Three Affiliated Tribes Constitution specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes for the Tribes; and
- WHEREAS, The Tribes seek a community-based facility to provide wellness, fitness and health education services for enrolled members of the Three Affiliated Tribes with diabetes; and
- WHEREAS, The Tribes seek to construct, manage, and operate said community-based facility as the "MHA Diabetes Education Center" in partnership with Elbowoods Medical Center; and
- WHEREAS, The Tribes have approved of the MHA Diabetes Education Center construction project; and



- WHEREAS, The Tribes have undertaken the initial design and planning of MHA Diabetes Education Center construction project; and
- WHEREAS, The Tribes engaged Nelson-Tremain Partnership, LLP ("Architect") for a total sum fee of Seventy Five Thousand Dollars and Zero cents (\$75,000.00) to provide for review by the Tribal Business Council the following services for the MHA Diabetes Education Center construction project: (1) pre-architectural space program; (2) site master plan; (3) building concept diagram; (4) building systems and materials; (5) design and construction schedule; and (6) budget estimate, hereby attached as Exhibit A of this Resolution; and
- WHEREAS, The Tribal Business Council, on February 12, 2020, engaged Architect for architecture and design services for the MHA Diabetes Education Center; and
- WHEREAS, The Architect has completed the Pre-Design phase of the project; and
- WHEREAS, The Architect has presented a proposal and payment, billing, and invoicing for its pre-construction phase work, attached as Exhibit B to this Resolution; and
- WHEREAS, The Tribal Business Council has reviewed proposal and payment, billing, and invoicing for its pre-construction phase work.
- NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby approves the Architect's proposal and payment, billing, and invoicing for its pre-construction phase work as set forth in Exhibit B; and
- **BE IT FINALLY RESOLVED**, the Tribal Chairman is hereby authorized to take such action as is necessary to carry out the terms and intent of this Resolution.



## CERTIFICATION
