

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION


A Resolution Entitled, "Approving and Authorizing Construction and Operation of the Mandaree ERC Upon Tribal Lands"

- WHEREAS, The Mandan Hidatsa and Arikara Nation (MHA Nation), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws (the Constitution) under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the MHA Nation; and
- WHEREAS, The Constitution authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the MHA Nation and of the enrolled members thereof; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of the Constitution, the Tribal Business Council has the power to adopt Resolutions regulating the procedures of the Tribal Business
- WHEREAS, Article V, Section 5(i) of the Constitution specifically authorizes and empowers the Tribal Business Council to purchase and manage tribal lands; and
- WHEREAS, The Tribe requires expansion of emergency medical and law enforcement services; and
- WHEREAS, To increase medical and law enforcement capacity the Tribe has undertaken construction of the Mandaree Emergency Response Center (the "Mandaree ERC Project"); and
- WHEREAS, The Tribe has engaged EAPC Architects Engineers to serve as the architect for the Mandaree ERC Project ; and
- WHEREAS, The Tribe has awarded the construction contract for the Mandaree ERC Project to Comstock Construction; and
- WHEREAS, The Mandaree ERC is being built upon land owned by the Tribe which is legally described as shown in Attachment A; and
- WHERAS, It is necessary for the Tribe to authorize and allow for the construction and operation of the Mandaree ERC on the land previously described; and



- **NOW THEREFORE BE IT RESOLVED,** that the Tribal Business Council authorizes and approves the construction and operation of the Mandaree ERC on the land described in **Attachment A.**
- **BE IT FINALLY RESOLVED,** the Tribal Chairman is authorized to take such action as is necessary to carry out the terms and intent of this Resolution.
