

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

## A Resolution entitled, "Consent to Certain Rights of Way across Tribal land for the Otter Tail Power Company Easement"

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and
- WHEREAS, Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, also known as the Mandan, Hidatsa, and Arikara Nation ("Tribes" or "MHA Nation"), the Tribal Business Council is the governing body of the Tribes; and
- WHEREAS, Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and
- WHEREAS, Article IX, Sections 1 and 3 of the Constitution provide that the Tribal Business Council has the authority to manage and lease or otherwise deal with Tribal lands and resources; and
- **WHEREAS,** The applications for Rights of Way (ROWs) described herein have been reviewed and recommended for approval in accordance with the MHA Nation's approved procedure for authorizing ROWs on Tribal land; and
- **WHEREAS**, The Tribal Business Council finds it appropriate to authorize the ROWs described herein, and to waive payment in consideration of the public benefit the granting of the ROWs provides.
- **NOW, THEREFORE, BE IT RESOLVED,** that the Tribal Business Council of the Three Affiliated Tribes hereby waives payment and consents to the following ROW(s):
  - 1. Otter Tail Power Company's Purpose of Easement is to inspect, survey, develop, install, expand, construct, replace, operate, maintain, repair, remove and demolish electrical facilities. Term: 30 years in accordance with the MHA Nation Public Utility Right-of-Way Consent Terms and Conditions, and containing .20 acres more or less. The easement is for Otter Tail Power Company across certain Tribal lands in:



a. County ID number – 580063723, SW<sup>1</sup>/<sub>4</sub>, Sections 24, T. 152 N., R. 90 W., Mountrail County, 5<sup>th</sup> Principal Meridian of North Dakota, with a 100% Tribal Fee interest.

A 10.00-foot-wide easement for underground electric across part of Lot 3, Block 2, Wild Horse Addition, Mountrail County, 5<sup>th</sup> PM of ND. The center line of said easement is described as follows:

Commencing at the northeast corner of said Lot 3; thence on an assumed bearing of North 88 degrees 46 minutes 44 seconds West along the north line of said Lot 3 a distance of 421.98 feet; thence continuing along the north line of said Lot 3 South 68 degrees 16 minutes 18 seconds West a distance of 73.19 feet; thence South 12 degrees 04 minutes 01 second West a distance of 155.99 feet to the Point of Beginning of the center line to be described; thence North 12 degrees 04 minutes 01 second East a distance of 149.97 feet; thence North 68 degrees 16 minutes 18 seconds East a distance of 75.53 feet; thence South 88 degrees 46 minutes 44 seconds East a distance of 215.51 feet; thence South 49 degrees 20 minutes 00 seconds East a distance of 230.74 feet; thence South 27 degrees 29 minutes 44 seconds West a distance of 66.73 feet; thence South 43 degrees 08 minutes 52 seconds West a distance of 97.20 feet and there terminating.

**BE IT FINALLY RESOLVED,** that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.

## **CERTIFICATION**


