## d) Tiger Grant

Ron Hall presented information about the transportation study and the resolution details previously approved pending further detail of the amount of commitment by the Three Affiliated Tribes and his contract. Resolution was numbered #15-023-LKH. The total budget for the 3-yr project was for 2 million dollars. Chairman Mark N. Fox stated that the Three Affiliated Tribes will be committed to the million dollars but will provide 1/3 of the amount per year, minus 100K already in the budget for this year. Chairman Mark N. Fox stated no motion is needed as the resolution is already approved; all that needs to be done is for the Chairman to sign off on the contract.

#### e) Crow Fair Arbor

Deferred to the April 9<sup>th</sup>, 2015 Tribal Business Council Meeting. Mr. George Real Bird III, Sylvan Covers Up, and Corrine Small approached the Tribal Business Council to seek a possible grant or loan to assist the Crow Tribe in their effort to rebuild the Crow Fair Arbor after it collapsed over the winter. The group presented plans and budget for the project. The projected budget of Phase I of the project comes in at \$768,028.00, working to secure 50-100K through the Tribes Economic Development Loan Fund. They are also seeking an additional grant from the State Coal Board that comes up next winter. Through fundraising effort \$250,000.00 has been raised. The Tribal Business Council was receptive to a loan and asked that Mr. Real Bird return to them with a letter from the Crow Chairman

supporting that offer before possible approval moving ahead with the details.

## f) Sponsorship Request-

The Tribal Business Council had a number of sponsorship requests and had a lengthy discussion the need for a policy to standardize the way these requests are handled.
