to FBDC Report presented. On 11/6/17 a total of \$2,173,919.87 was owed to the court for fines/
fees. As of 7/31/19 a total of \$2,069, 734.10 is owed to the court Since the project beginning
January 1, 2018 the court has brought the receivables down by \$104,185.77 including assessments
made to defendants in 2018 and 2019. Peoples Fund Disbursement August 2018 (submitted 340
delinquent accounts = \$915,170.64, received \$92,173) August 2019 (submitted 570 delinquent =
\$214,796) The cutoff amount was \$500 for individuals. August disbursement is pending. When the
project of "Unapplied Fees" is completed the Accounts Receivable amount will be lowered by
\$241,683 which will change the receivables number to \$1,828,051.

C. Public Safety Division of Drug Enforcement – Gerald White, Jr., Chief

Special Agents Tyler Welk & Derrick Bourgue presented the Report. Six (6) federal search warrants obtained re a Hispanic Drug Trafficking Organization (DTO) suspected of distributing methamphetamine and fentanyl based pills throughout Fort Berthold. Two enrolled females and one enrolled male indicted by a Federal Grand Jury for a variety of federal drug offenses. Special Agents (SAs) have made a number of controlled purchases of a variety of controlled substances, to include methamphetamine, oxycodone pills, and heroin. On one occasion, approlimately 58 grams of suspected methamphetamine and 34 purported oxycodone pills were purchased. SAs have assisted Three Affiliated Tribes Police Department (TATPD) and New Town Police Department (NTPD) in the seizure of three stolen vehicles and the arrests of those involved. SAs have responded to assist TATPD/TPD with a number of reported overdoses/medical calls and initiated case-related follow-up re each. SAs responded to a reported stabbing in Parshall and ultimately worked through the night with TATPD/FBI, to include assistance in drafting the federal search warrant affidavit. One arrest was made and SAs assisted in the collection of evidence. SAs assisted in the arrest of a previously convicted African American male and two firearms were seized. SAs investigated a marijuana distribution 1 ase in New Town/Parshall involving an African American male that ultimately went to a jury trial. After testimony, defendant was convicted on all counts and sentenced to North Dakota Department of Prisons. SAs have given various presentations to community members/groups/schools. K9 assisted Williston Police Department in the recovery of a deceased person. SAs and K9 personnel worked enforcement at each Pow Wow/Segment Celebration. On July 18, 2019, SAs intercepted an African American male and an enrolled female on Fort Berthold after the male arrived by train to ND. A K9 traffic stop led to the seizure of approximately 178 purported oxycodone pills. It was determined the male had a pending arrest warrant was issued for



his arrest in Michigan for Absconding. He was arrested and will face extradition. On July 19, 2019, based on the above seizure of pills and subsequent investigation, a tribal search warrant was obtained/executed in Mandaree. An enrolled member/resident was found to possess suspected drug paraphernalia and arrested. On July 20, 2019, based on continued investigation and the receipt of Tip 411 leads, an enrolled female was stopped during Mandaree Pow Wow/Celebration. That stop and investigation led to a search of her residence and the seizure of numerous items of suspected drug paraphernalia. Later, on July 20, 2019, as the above referenced investigation continued, and after surveillance of another residence occupied by two enrolled members and observations of suspected hand-to-hand transactions, SAs and K9 personnel searched another residence in Mandaree. Agents located an African American male, who was in possession of approximately 57 purported oxycodone pills and in excess of approximately \$8,000 in United States currency. McKenzie County Sheriff's Office and the Northwest Narcotics Task Force responded to assist. One arrest was made. On July 22, 2019, an enrolled female was stopped by K9 in New Town. SAs responded to assist. Investigation at the scene of the stop led SAs/K9/NTPD personnel to search an enrolled member's residence in New Town. Agents located another African American male, who was found to possess approximately 126 suspected oxycodone pills and approximately \$10,346 in United States currency. SAs have submitted in excess of four 960's re those suspected of being involved in the abuse of controlled substances and endangering the welfare of enrolled children. SAs have secured and executed or assisted in the execution of an additional three (3) state search warrants and two (2) tribal search warrants. One of the warrants resulted in the seizure of approximately 456 grams of meth, thirty (30) grams of cocaine, and 58 purported Ecstasy tablets. In addition to daily K9 arrest stats, SAs have been responsible for or assisted in the arrest of seventeen (17) enrolled males, thirteen (13) enrolled females, eight (8) non-enrolled males, and one (1) nonenrolled female. Brittney White discussed TAT email problems and establishing a separate email service for Public Safety. Chairman Mark N. Fox asked that they insure the security and policy is implemented.
