The draft of FBDC survey was finalized with input from the Justice Commission; it was mailed to attorneys. (2) Currently have a one position not filled and that is the court advocate who will be in the Public Defender's office. (3) Interviews have been conducted for other court positions and have been hired, Cassidy is working on getting paperwork through system. Continue to locate people/organizations to conduct training for clerks. We are in the process of a "clean up of the Full Court files". Many of our FBDC files were incomplete and need updating because of the high turnover in court staff in previous years, and because of moves; this is a huge task and will take months to complete. The Court Manual has been completed, we will duplicate and distribute to all court staff. Continue working on the Tribal Codes; Justice Commission met September 20 and had teleconference with Sharon Thompson on a team/task force effort to code amendment. Court staff members and Chief Judge Seaworth attended the National Tribal Judicial and Court conference in Minneapolis. Have new Magistrate Foote Shadowing Judge Jackson, Judge Seaworth and Judge Heart. Court is looking for an opening in training in Reno NV at the National Judicial College. Found an IT person for the court.

#### XV. CULTURAL COMMITTEE - Chairman Randy Phelan, Chair

A. Support Request – Ryan Wilson

Requesting \$15,000 in support from the MHA Nation to ensure that activities surrounding the reauthorization/ Appropriations campaign are sufficiently supported and that a successful conclusion can be reached in this Congress. This critical investment will be used to fund the publishing of Briefing Papers, Testimony, and Advocacy letters. It will also be used to fund a Congressional Briefing, and a Congressional Reception designed to heighten awareness and elevate the issue within House leadership. Native American Language Preservation Act was reauthorized asking for \$15,000 to the National Indian Education Association. Councilman Randy Phelan noted that there is a \$5000 limit policy.
