#### **D.** Mineral Return – Marcus Levings, Marvin Danks

Have been in the works for 28 years. We would like to present the committee with our concerns. Would like to move forward with this mineral return. Marcus would like these to go back to the rightful owners. We would like to correctly present this to Council. A second law passed in 1994, and has not moved since. We have a Resolution in draft form. Mervin stated most of his family is gone; we need to look out for the children. John Fredericks spoke about the legal parameters of the big Missouri. The River Bed will always belong to the tribe and allottees. The Tribe does not have to convey only congress can do this. Asking for support for the fight for allottee mineral return. Chairman Mark N. Fox states he is an allottee too. We need to have a work session on this. Need to have a work session.

*Motion:* Councilwoman Monica Mayer moved to approve a full work session, and work on a resolution to support. Councilman Fred Fox seconded the motion. Vote: 5-0-0. Motion carried.

#### F. Emergency Response Center - Mary Fredericks

The Emergency Response Center is ready for electric service hook up from McKenzie Electric. They wanted \$57,000. There is a 20% cost increase due to having to get a Right of Way. If we do our own Right of Way, we can take \$15,000 off of that. The Right of Way is on Tribal land. If Mary can get the ROW she can give it to the electricity company. Need to have ROW done by TBC.

*Motion:* Councilman Fred Fox moved to forward to TBC. Councilwoman Monica Mayer seconded the motion. Vote: 5-0-0. Motion carried.

#### G. Range Unit 204 - Danny Hall

Kayla Danks asked if there was another resolution issued on Danny Hall. She has a resolution but it is unsigned. He wanted to exchange 120 acres for 120 acres. 79 acres of tribal land, Allotment no. 301797A for 26.67 acres of Danny's land. Allotment no. 301798A for 39,99 acres. Allotment 800A for 40 acres. Total of 186 acres, Danny Hall's land is 106 acres, 79.65 for tribal acres. Total appraisal of Danny's land comes up to 100,317.64 and the appraisal for the tribal is 111,510 for the tribal tract. Danny Hall states when he purchased the land it was 40 acres, 40 acres and 40 acres and now they have him down to 106 acres. Danny Hall states he should have 120 in Mandaree. Danny Hall wants to trade acre for acre, but should be value for value. Danny Hall bought 120 acres and BIA only shows he has 106 acres. This has been going on for thirteen years. The two issues that need to be resolved is Danny bought 120 acres and only 106 is recorded at the BIA and Danny Hall is trying to trade acre for acre but there is a law that he has to go value for value. Texx Lone Bear will help Danny Hall meet with the BIA. They need to set up a meeting. Texx Lone Bear has a resolution but does not have amounts.

*Motion:* Councilman Fred Fox moved to forward to TBC. Councilwoman Monica Mayer seconded the motion. Vote: 5-0-0. Motion carried.

#### H. Fort Berthold Rural Water (FBRW) – Pem Hall, Director

Presenting a resolution for the installation of a rural water pipeline on tribal fee land in the Thunder Butte area, section 20. The resolution is under Legal review.

*Motion:* Councilman Fred Fox moved to forward to TBC. Chairman Mark N. Fox seconded the motion. Vote: 3-0-1. Motion carried.
