M. Mandaree Electronics Corporation (MEC) – Clarence O'Berry, CEO

2020 Capability Presentation for Northrop Grumman Corporation submitted. Mandaree Enterprise LLC. (MEL), that is a Small Disadvantaged Business and Native American, Tribal Owned Corporation with three 8(a) companies and various small disadvantaged business units. MEL businesses pursue a variety of contracts including: 8(a) competitive and 8(a) sole source, Indian Economic Enterprise, and Total Small Business set-asides. Our contract capture strategies integrate joint ventures- both between MEL firms and with outside entities and Mentor-Protege



relationships. MEL owes much of its growth and current success to its first Department of Defense Mentor-Protege Agreement, established in 1992 with Northrop Grumman Corporation (NGC). The Mentor-Protege team of NGC/MEL received two Nun-Perry Awards, this relationship prepared MEL to pursue prime contracting opportunities, to build a diversified portfolio of competencies and customers, and to establish an expansive corporate footprint CONUS and OCONUS. MEL shared ownership and leadership, all MEL business units' share services that include Accounting, Human Resources, IT Services, and Proposal Management. As tribally-owned entities, MEL companies are also entitled to share past performance qualifications in the pursuit of contracting opportunities. MEL is owned and operated by the Three Affiliated Tribes of the Fort Berthold Indian Reservation in North Dakota.
