**A. Elbowoods Memorial Health Center (EMHC) Update\* –** Dr. Kathy Eagle, CEO & Anita Martin, CMO.

Submitted report for the record. Have received all COVID funds and working with finance to process the funding. Working the EOC to transfer DHHS funding for Provider Relief for \$2.5 million one-time payment the EMHC received. Have met with State tribes to develop a plan to share resources due to the COVID hospital surge. Discussed strategies to serve tribal members in the event of State's hospital system reaches capacity. Emergency medical locations have been identified at the New Town High School & the old New Town nursing home (Isolation Center). Councilwoman Monica Mayer provided an overview of the process of diagnosing and isolating Covid positive patients and noted ER's would not send patients back to the reservation for care. The Isolation Center can be used for isolation but not ventilator care. The facility has 20 beds and appropriate facilities in each segment need to identify places too. Most of the segments have purchased fogging machines to sanitize segment properties. Report on recent COVID testing and adjusting to the colder weather. I.H.S. Expansion funding for Ambulatory Care Joint Venture construction being used for Dental & Optometry facility to be used for staffing. Chairman Mark N. Fox discussed an opportunity to bring mass rapid serology/antigen tests to the reservation. John Fredericks noted a meeting with Indian Affairs to discuss a vaccine event.

What is the status of consultant contract for Sommer Turner as the court drug evaluator? MHA needs a Licensed Addiction Counselor, 2 would be better. This leads to the concern about transportation which we will hopefully resolve when we have our Wellness meetings and are able to coordinate through the entities involved. 2. MHA needs a mental health staff member to deal with the mental health issues in the Wellness Court. 3. The budget continues to be a concern with the Court as we update staffing. Also, with the risk assessment we feel it is necessary for updates of our equipment, and building maintenance such as security. Discussion of Jury Trials & mitigation. The Court receives about 3 EDO's/week but many don't include a mental health evaluation and transportation.
