The Court has been working with Sharon Thompson on the updates for the maintenance of the Court building. Chairman Mark N. Fox would assist with payment of invoices. Reported that there are 31 FTE staff with one position open (Wellness Court Coordinator/Clerk). Continued virus mitigation of the Court facility continues. Court files & FullCourt work to clean up files dismissing old cases prior to 2011-14. Bond cleanup continues with letters going out with Show-Cause Hearings. Developing Personnel Policies & updating Organizational Chart. Web site development continues. Developing an examination for incoming tribal advocates and lawyers. Developing Rules of Professional responsibilities for the Tribal Bar members. Monthly meetings with Law Enforcement and more recently with the Justice Center. Evelyn Wounded Face, Business Manager continues to do an outstanding job at creating policies. Chief Judge, and Court Administrator met with Randal Lindemann (the original architect) regarding the equipment and building maintenance. This was a very good meeting. We are now waiting on a meeting with the Chairman and others involved to put a plan in place to resolve building issues. In December the Court had some outlets turn off so we called AVI in Minot and fortunately the person who originally worked on the Court building was in New Town and was able to look at the electrical system and resolve some issues, but told us they will probably charge us for his visit. After the Judicial Committee meeting it was recommended that the Court contact Dennis Fox who is the construction manager for the tribe. With the need for the Wellness Court personnel, supplies, etc., and updates of our equipment and building maintenance we are continually reviewing our budget since these were not in the original court budget. The Court plans on revising our budget to include building maintenance as well as more staff and supplies for the Wellness Court.


