Motion: Councilwoman V. Judy Brugh moved to approve the December 28th, 2020 Health & Human Resource Committee Minutes with corrections. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.

V. PROGRAM UPDATES

A. Elbowoods Memorial Health Center (EMHC) - Kathryn R. Eagle-Williams, MD MPH, CEO MOU from VA-IHS was presented to Committee, Elbowoods to bill for Veteran services. EMHC established a resolution for this several years ago but we are still working with legal the actual contract. Home based health care at EMHC will be asking for scope of work so we know what each of the segments are capable of, so when patients come to EMHC we know what we are working with. Councilwoman Monica Mayer states the segments are building their own health care programs because the tribe is unable to fulfill a home health program even though they receive federal funds for it, and it is still nonexistent. Before there was only one home health nurse who couldn't cover North Segment. Now there are 3 health care people in North Segment from EMHC. Elbowoods needs to know what services are available to assist all needs. Councilwoman V. Judy Brugh asked if it's billed from that for the nurses, no. North Segment have about 8-9 health care workers. Have started billing from QSP. Councilwoman V. Judy Brugh and Councilman Fred Fox started this in their communities also. Councilwoman Monica Mayer states this should all come out of federal funding. We would like to have a working session. The Tribal Health Program needs to be revived. Dr. Martin updated committee on vaccine schedule. More side effects with the second round of the vaccine. No severe issues. Shared demographics on the vaccine. Have to use the vaccine one week within getting it. The vaccines comes directly from the company. Contract for Trauma Informed Care and Practice, PLLC. Amendment to consultant contract between TAT EMHC and Trauma Informed Care and Practice, PLLC. Councilwoman Monica Mayer mentioned, what should be first is how do you do the federal funds being sent first. Then we could ask the judge for restitution. Tammy DeCoteau contract, Through Dec 31th that would be the amendment. Also added in tele medicine.

D. Good Road Recovery Center (GRRC) – Dashell Thunder

Councilwoman Monica Mayer requested all standing program reports be sent to Lexi. Have 6 males and 3 females at Good Road Recovery. Have room for 2 more females and a couple more males. On outpatients we have 17. Have 2 addiction councilors. One of the Councilors is out for a short while. We will contract to bring one more on. One of the programs goal is to be at a 3.5 ASAM intensity care. GRR is at a 3.1 currently. Some of the clients are over this and are not able to be on the program. Need more staff, councilors and medical staff in order to extend our hours of service. Have 14 staff and gave a total for budget. Need extra for salaries for 21 FY budget is \$4,774,013. Councilwoman Monica Mayer suggested he put together a report and bring to TBC, existing staff, names of positions and vacancies. 3.2 million Budget now (from tribal), need to be at 3.5 for the salaries. Need billing and revenue generating. Last 6 month daily average for female and male occupants. This will help clarify need. Put together a complete report.

Motion: Councilwoman V. Judy Brugh moved to forward Good Road Recovery request for staffing and budgetary management to TBC. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.

Deadline is April 22nd, TAT Law Department states they can change the date. Feb 11th is the next TBC, which is enough time to submit the grant. Dates need to be changed.

R. Medical Bills – Connie Azure

Medical request for daughter Janice Hall has had open heart surgery by time she was 2 year old. She had a stroke. The last 2 years we had to go to Mayo and see urologists. Have a lot of medical



expenses, she has second insurance. Exhausted all avenues. She is on Life & Limb and that covers hotels and mileage. Most of her expenses have not been paid by insurance. She took her daughter to IHS for her medical issues prior to us being referred to a Children's Hospital. Last year we were told we won't be helped because we are out of the service area. Boon Insurance has not been paying. She has been declared 100% disabled. Looked into Medicare but due to income she is not qualified. Had a \$1,000 deductible last appointment. Councilwoman Monica Mayer states, we need to have a review of bills, EMHC and Boon Insurance need to go over these bills and figure out what can be helped with. Ask for an audit for her bills which are in collections now. Kathy states they might be able to get medical care, if we can do an audit. Lexi will contact Pam Lewis (Tribal-Care) and will review the case and why some bills have not been paid.

Motion: Councilwoman V. Judy Brugh moved to forward to TBC after the audits are done. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.
