3) New Town Schools - Beth Zietz, Superintendent Current Fiscal Year Budget: \$22,502,685.12. Expenses to Date this Fiscal Year: \$9,961,086,14 (45% of the budget expended). Student Population (K-12): Student Population (K-12): 935 students (826 or 88% American Indian students). Ethnic Diversity of NTPSD#1: Teaching Staff (99): 48 Non-Indian (48%), 1 0 American Indian (10%), 41 Other Minority (42%). Administrative Staff (9): 8 Non-Indian (89%), 1 American Indian (11%). Winter Sports/School Activities Completed (Wrestling Completed; Varsity Girls Basketball Completed: Region Qualifier; Varsity Boys Basketball Completed). Spring Sports/School Activities Underway (Boys & Girls Track; Boys Baseball; Girls Softball: Inaugural Season; Speech; Eagle Feather Indian Club). 79% of Students are Attending School Daily and 21% of Students are Attending by Distance Learning. Afterschool Tutoring, Saturday Academies, and Noon Tutoring Across the School District Continued. Backpack Program (Weekend Healthy Food for Needy Students) Continued. Consolidated Construction of Bismarck was Selected as the Construction Manager at Risk for the High School Addition Project (Auditorium; Music Room; Kitchen Storage; Wrestling Room; Weight Room; Locker Rooms; Storage Area); Prep Work Continued. The Superintendent has a couple requests. NTHS has a 1:1 Computer initiative, on distance learning we distributed machines to students to have at their homes. What we found is we have a lot of breakage, loss and unfortunately machines sold on line. When the students came back they are in tuned to learning to use technology in learning. We talked about how are we going to get technology into every classroom. We are still in the planning stages that the only way we can efficiently do this is placing a computer cart in every teacher's classroom. What that does is we will have more computers than kids. Have about 40% of students that were not taking care of the laptops tops at home. The Superintendent is not sure who to go to for additional funds. Requesting funds to match a grant, in order to have laptops in each of the classrooms over the next three years. Looking for about \$500,000.00. The Superintendent is asking where to take this once the full initiative all worked up, explained, and have the actual cost numbers. Councilwoman Monica Mayer suggested have the school or school board submit us a breakdown of your budget for the 1:1 Computer initiative. We are supportive of the technology after handing out all of those IPads. Some IPads were sold and people were asking North Segment to purchase more. North Segment does not have the budget to cover this. The Superintendent was asked to bring in the budget into the next Education Committee so they can see the breakdown, the more planned out it is, the easier it is for Committee to get it passed and find the funds for it. Would need to put this Initiative in for next fall. The Superintendent will bring in the budget to the next Committee meeting for the next TBC.

Needs to get on the next TBC agenda for CIS. Working on the Backpack order, spent \$25,000 at Scheels. It has been hard to pass out backpacks due to COVID. Don't really have storage to hand out for next Fall school year. Councilwoman V. Judy Brugh suggested she could give the backpacks to the Segments to hand out. The Superintendent is concerned with the children between the times of 4:00PM to 8:00AM, need to remember these are the time they are not in school. We all need to collaborate and have events/programs for youth. An issue is some children have to watch younger siblings when out of school. Councilwoman Monica Mayer informed we have Native American Fatherhood & Family Association in New Town. Councilwoman Sherry Turner Lone-Fight would like to hold GED classes in Mandaree again.
