A. Public Safety Division of Drug Enforcement

Report submitted for the record. Banishment of Drug Dealers from Fort Berthold (Code). First banishment was Michael Smith. Legal is still reviewing resolution for banishment of Jumero James.

Report submitted for the record. Wellness court has been pushed back a week to continue to hire a coordinator. There will be an application for the court. There is a cultural advisor on the board? There is a board and there is an elder on there. Sharon Thompson via conference call, she is working on the policy and procedures should be ready April 12th. Sharon explained the policy for wellness court. Councilwoman V. Judy Brugh feels strongly there needs to be a cultural advisor on the board (an elder). There will be a cultural component to the wellness court. An elder from each community would be good. People on the steering committee have been working on a list. Court needs two Magistrates and a Judge. Sending the information to HR. Wellness Court would take place once a week. Finance wanted the budget. Councilwoman Monica Mayer feels the case manager needs an assistant. Need a resolution to direct everyone to know who is doing what. In the long run we will need to extend an EDO. Councilwoman Monica Mayer states we need someone here in Fort Berthold to assist with the treatment. Councilwoman V. Judy Brugh states, we should address this in a health working session.

F. Gerald Tex Fox Justice Center (GTFJC) Juvenile Detention – *Mike Young Bird, Administrator*

Report submitted for the record. In February we had (12) youth who received services. We had (4) 960's filed and (1) forensic interview completed. We are screening youth upon arrival into the justice center and taking daily temperature's for Covid precautions. We had (0) referrals to COL, (0) to Summit Counseling, (2) to North Central for court ordered evaluations. There was (1) youth placed at Eckert, (1) at Great Plains Treatment Center. We have one youth who is at Dakota Boys/Girls Ranch in Bismarck. We had (9) youth test positive for marijuana, (0) for opioids, (4) alcohol, (4) fentanyl, and (1) ampletamines. The number of youth on fentanyl was lower this month, but several other youth reported using fentanyl but it did not show in their test. Youth report that it is very accessible to them. We continue to serve the youth and their families the best we can through these challenging times. We are seeing youth who have lost very dear family members due to the pandemic. Youth we have come through are doors are amazing youth with so much potential.

G. Child Support – Alison Johnson, Director



Report submitted for the record. Child Support guidelines have to be looked over every four years. In 2009, there was an out dated system, no replacement has been found for that system. We felt it was better to use gross income instead of new income and self-employed. Have three categories. Want to take this to TBC for approval. 704 open cases, 90 some that don't pay child support. The new guidelines will touch all the categories.

Motion: Councilwoman Monica Mayer moved to forward guidelines to TBC for further discussion. Councilman Fred Fox seconded the motion. Vote: 4-0-0. Motion carried.

FTR: Councilman Cory Spotted Bear left meeting.

The building the facilities did not work for a few weeks when the pipes froze. Have a leaking roof. Have been approved in 2019 for a new building. Councilwoman V. Judy Brugh asked why can't we get them a place. The CEO's office was working on this. There are nine staff at Child support. Councilwoman V. Judy Brugh will have her staff look for a home for Child Support office. Robert White out of Four Bears office will look into a place.
