#### **CALL TO ORDER:**

Councilman Cory Spotted Bear called the meeting to order at 12:06 PM.

## A. Natural Resources Dept. - Texx Lone Bear, Director

Texx Lone Bear states his computer crashed in Natural Resource. He has a land sale, not sure if everyone has gotten and appraisal for the old Super Value building. They are asking for \$375,000. It is appraised at \$290,000. Range Unit 20 (Rick Little Swallow), 903 by Four Bears, range unit 906. Mandaree land and livestock had some interest in it.

#### 1) Home Sites

Home site leases are Charles Moran Jr., Shana Taft and Daniel Chase. Council woman Monica Mayer states there are residence that need homes, Van Hook has leasers that haven't use the lot of land. It is only for 1 year, if there is no structure, lease is null. Bring in the leases over a year old to TBC for lease to be canceled so others can occupy the lot.

*Motion:* Councilman Fred Fox moved to forward home sites to TBC pending Legal review. Vote: 3-0-0. Motion carried.

Discussion: Texx Lone Bear will get a disapproval in White Shield and recommended deferring. Texx asked if a previous home site leaser is taken off the resolution, will the council make a new resolution or to amend. Texx will check with Legal first before any formal action.

## C. Medical Request – Grace Gillette

She has some work done and has 2 bills for \$1,249 and \$1,802 would like to be reimbursed for these. She lives off the Reservation and Boon Insurance did not cover it. Councilwoman Monica Mayer could not reimburse amount out of North Segment funds. The total amount is
