And they'll be part of a community of practice that's building their ability to create wealth and foster economic development, create jobs, build capacity and develop a workforce, and create a just and sustainable future for people in our communities. #### G. MHA Interpretive – Delphine Baker, Director

Report submitted for the record. In one month, the Interpretive Center made \$64,000. She is setting up an endowment fund, she needs to meet with the CFO first. Councilwoman Monica Mayer states this should be presented at the upcoming budget meeting. Delphine needs to meet with the CFO to create a line item for the gift shop and the coffee shop. When the interpretive center makes money it comes off of the budget, the budget keeps getting smaller. Councilwoman states the Segments all gave \$700,000 to North segment budget for youth and elders. That money is gone, she has no idea where the rest of the money went. Delphine has a credit card set up now. Councilwoman Monica Mayer states the Tribal Finance Department needs create a Business Management Department. The Interpretive has a business side and a nonprofit side, everything goes through the Finance Department. Delphine needs to hire 2 cooks, it's hard to do a temp hire. She is paying people as vendors for now until she can get to the hiring. She is requesting a summer youth worker. Councilwoman



Monica Mayer told her to hire one and put them under facilities. There are 2 youths in the coffee shop and 2 youth in the gift ship, just need to have one for the facility.
