**A.** Tribal Court Report\* - Elizabeth Yellow Bird & David Christenson, Chief Judge Insert Report. Chief Judge David Christenson recognized the service of Prosecutor Rob Ackre. Continue to provide services to MHA nation and public with consideration given to COVID protocol 2) FBDC has 33 full time staff (3 are under contract); we have 2 bailiff positions, a Juvenile probation officer and the Case Manager of Wellness Court positions open and being advertised. The Court continues to work on getting a fulltime maintenance person for the Court building, this position is being re advertised. The Wellness Court continues as a priority and is evolving with some changes and updates. The Wellness Court staffing's will be on Thursday's, and the docket will be held after that. We are planning a meeting with the Elders board this month after we receive the TBC appointees. Kelly Fox has resigned effective June 30<sup>th</sup>. Verdell Thunderhorse is doing an excellent job and has some new ideas for the Wellness Court. Judge Louis Gwin has been doing a wonderful job as the judge and working with the juveniles. The Court continues to address COVID 19 epidemic and will be enforcing the mask mandate again because of the Delta virus. The Court will be screening at the entry for all public and staff who work in the building, face covering for everyone and regular cleaning and sanitizing this facility and practicing social distancing. We have purchased a sanitizer for the court. We continue the "clean-up of the Court files" as well as



finishing up filing the boxes of documents from the old court building. This has been a priority and hopefully we will get this finished by this summer. The Court plans on utilizing "imaging" application through Full Court and should have all the files digitized within the next year. We are planning on on-site training/support sometime in the next month, but are waiting on the final contract with Justice Systems. The Court continues to work on our own Policies and Procedures Manual. A draft has been completed and was sent to the Justice Commission for review and approval. We are including all the updated forms the court uses in the manual and on our website. The Court continues to address the Tribal Codes by working with the Justice Commission and the TBC Legal department. A working session is planned through the Judicial committee on Friday July 9th. Another priority is that we are scheduling jury trials, as of today we have scheduled 9 jury trials, however the list changes often depending on each case. The Court is setting up a meeting with the Police department to develop a training plan for the new probation officers and the bailiffs. The Police Chief has agreed to meet with the Adult and Juvenile Probation officers and Bailiffs to do training by the Police instead of hiring outside people. The Court is reviewing our budget and will be having a meeting regarding the unmet needs for the next budget period. The Court participated in NAFFA training June 28<sup>nd</sup> to July 2<sup>nd</sup>. We had 8 participants, 6 from the Court and 2 from the Police Department. The Court continues to meet once per month with the Justice Center, PD and the Court to review any issues. These have been very good meetings and lets all departments know any issues or concerns and updates. The Court participated in the Wellness Conference on June 22<sup>nd</sup> and 23<sup>rd</sup>, Two of our judges participated in one of the sessions. The Court is considering closing the Court window during noon hour. Because of the number of cases the Court has we are also considering adding a clerk case manager who would monitor all civil commitment, child protection cases and wellness court cases; schedule follow up hearings, maintain court documents, correspond with staff, departments and facilities pertaining to the case, and maintain statistics; keep track of all cases, make sure all documents have been entered. We are planning a meeting with staff to discuss this position. The Court has requested active shooter training for the Court and Police departments. Because of the passing of the Court Prosecutor, that office is working hard to keep up with daily responsibilities. The Assistant Prosecutor has taken over the duties but will be out at the end on the month to take the bar examination, we are preparing for this now. Councilwoman Monica Mayer asked for the Court to look into having defamation being included into the Tribal Code.
