# G. Range Unit 204 – Susan Fredericks

She was not given notice to get range unit 204. She asked for 100%.

FTR: Councilwoman Sherry Turner-Lone Fight and Councilwoman Monica Mayer joined the meeting at 12:28 PM.

Councilwoman Sherry Turner-Lone Fight states Danny and Wilbur Hunts Along were nice enough to let her use it for a short while, according to the resolution it is Wilbur's Lease. When we split range units it causes families to fight among each other. Councilwoman Sherry Turner-Lone Fight emailed the letter and resolution to all the Committee on July 11. Wilbur took her to court, and there is a restraining order to stop them from doing anything with Range Unit 204. She is asking to be affirmed at 75% for grazing purposes. Councilman Cory Spotted Bear suggests to let the court case finish before bringing it back to Committee or TBC. Councilman Fred Fox asked, when is the allocation date? November 2021. Range units will be today. Lloyd Vigen explained the units, allocation and competing against nonnatives. The BIA has to abide by our resolutions. Councilman Cory Spotted Bear asked since there is a scoring system, why has he not seen any scores.

#### H. Emergency Feed Program - Lloyd Vigen

There are 47 applicants. The amount of animals 6,900, \$214,489.00. No applicants were turned down. The date was extended to get more applicants. Councilman Cory Spotted states, there are 4 people in Twin Buttes that applied but he doesn't see their name on the list. Closest feed store is in New Town United Quality could carry, but will have to have a list of people for a certain amount of feed allowed, Mandaree and Twin Buttes will go to Killdeer. Would have a check ready for United Quality if they purchase from there.

Everyone on the list are in dire need of feed. There is a person north of Bismarck that has 6,000 acres of corn who will cut and wrap the bails at \$120.00 per ton and deliver to Fort Berthold. There will be 12,000 tons. He would hold 10,000 tons that will be delivered to Mandaree. 1.2 million cost, but will try to negotiate down.


