NEW BUSINESS:

A. Medical Request - T. E.

The individual was born with Dental issues and has acquired a \$2995.77 bill. Requesting assistance to pay bill. He has had multiple braces, surgeries, bridge and implants. The individual does not have Boon insurance, he has other insurance. He is not under Grants & Donations. Committee decided if each Segment could match, the bill can get paid. The bill needs to be paid by September 3rd. North Segment staff will route the paperwork.

B. UND Tobacco Survey - UND Tribal Tobacco Control Project Coordinator Kalisi Uiuave called into the meeting, he is the UND Tribal Tobacco Control – Project Coordinator. An Inde3pendent Contract Services Agreement Between the Three Affiliated Tribes and Hawkvision Ecotherapy and Consulting, LLC was presented. UND is doing a tribal tobacco survey, everyone will receive \$20 to complete the survey. All surveys will be compiled for the state for budget purposes. Councilwoman Monica Mayer asked, "does this need an IRB"? Councilwoman Monica Mayer suggests to present to full council requesting to do a full survey. Will need to forward to TBC.

C. Amy Mossett

Amy turned in her report and was asked to come back after she compiled the Mitigation and Vaccination. There is a district wide mask mandate in White Shield, Mandaree and New Town. Total number of students K – 12 is about 1,700. Children 12 and older are eligible to get the vaccine. There are 730 students that are over the age of 12. Working with 2 budgets currently. Councilwoman Monica Mayer asked where is our ND Education department and Tribal Education Department sit with covid care act monies. Amy states their department has not received any funds. The schools are receiving monies. The spending plan was due last month. Amy feels her office would be able to receive covid monies. Councilwoman Monica there are no school nurses, it is important to test and treat covid students. Amy states the New Town schools have 3 nurses. Councilwoman Monica Mayer asked if the education department should help assist with getting nurses for the segments. North Segment and New Town schools are fogging down to keep covid cases down. 8 months after the vaccine you are eligible the booster, Dr. Martin states those with underlying health. The elder are not including in the booster shot. CDC has not put out the vaccine yet. There have been 16,000 testing done, 800 plus tested positive. Councilwoman Monica Mayer asked if Mandaree School can share their audits.

D. Dental - Alkire

The Parent to child has Boon Insurance. The procedure was done 6-19-2017. Lexi turned it over to Tribal-Care. Lexi shared the information with the committee. There was a hospital stay and it was coded under dental, they need permission to pay these bills to Trinity. \$5, 908.05 and \$7,289.15 are the amounts that need to get paid, it will go to collection soon. Need approval to pay these bills
