B. MHA Education Department - Amy Mossett, Director

The Director is requesting a budget modification from the FY 21 as we had considerable savings in our salary line item. We had two positions in our office that we did not fill due to COVID and one position we did not fill as one of our school districts requested that we hold off on the positions. All positions will be filled in the current FY22 fiscal year. I am requesting a 100/0 merit increase for Marie Driver, Education Advocate Supervisor; Beverly Bird, Education Advocate at Edwin Loe Elementary (531 students) and myself- Education Director. The current and proposed hourly rates follow. My justification for this increase is that during the past year and even more so now, we've taken on additional COVID related duties serving our schools, parents and students with daily attendance follow-up, wellness and homework checks with quarantined families, maintaining communications between our schools and families and between our department and the schools, and delivering school and department resources to families. During periods of minimum staffing the only two employees who were consistently and regularly present in our office were Marie Driver and me. Beverly Bird has a bachelor's degree in Education and many credits toward a Master's in Education. She is the lowest paid of our Education Resource Advocates, is working tirelessly with our largest elementary school, has excellent work attendance, work ethic and work performance and has joined Marie and me when we've worked into the evening with backpack distribution and other department events. In lieu of a COVID bonus which none of us received for additional COVID related work, I am requesting that our merit increase be effective back to January 1, 2021. I am also requesting the purchase of a (mid-size) pickup truck with a topper or a midsize van to transport supplies and equipment for our events and backpack distribution. I've been using my truck which has a large truck box and topper but my vehicle has 95,000 miles one it. The Education Department is looking for additional office space.

Motion: Councilwoman Sherry Turner-Lone Fight moved to forward Merit request, vehicle request and need for more office space to TBC. Councilwoman V. Judy Brugh seconded the motion. Vote: 5-0-0. Motion carried.

C. MHA Education Pathways - Barb Anderson

Report submitted for the record. RAIN Director Deb Wilson retired as of July 31. 2021. Barb Anderson was hired as the new Director of RAIN as of September 16, 2021. DeLana Wendland, UTTC MHA Mentor resigned her position as of July 30, 2021. We did advertise and interviewed one person for the position, she declined the job offer. We reopened the job announcement with a new closing date of October 5, 2021. Mentor Report: All of our Mentor offices are now open and functional, with Covid-19 guidelines in place. Two of our Mentors, Evelyn (Faye) Foote and Corey Sanders, set up and participated in the 2021 Fall United Tribes Technical College (UTTC) Career Fair earlier in September, to provide outreach and awareness to our MHA enrolled members in the Bismarck/Mandan area. Contacts were made with additional MHA students in the Bismarck/Mandan area. The program is now under the leadership of Barb Anderson, who was officially hired and accepted the position on September 16, 2021. Barb has been a part of the Pathways leadership team since the program's inception, so the transition has been an easy one for us. All staff attended the RAIN/MHA Education Pathways Program Team Building sessions on July 14-15, 2021 in Grand Forks, ND. Upcoming Events for October: Two of our Mentors Ardith and Evelyn will be attending the National Indian Education Association Conference from October 13-16 in Omaha. Corey will be participating in the Fort Berthold High Schools College Awareness and FAFSA day at New Town High School on October 15.

D. Head Start Program - Kelly Bradfield, Director

Submitted the HeadStart Program Governance Reference Book, Performance Standards for the Committees review. Also presented a Service contract for cleaning services, it went through legal. Down South Roustabout is the cleaning service.
