

# THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL NATURAL RESOURCE COMMITTEE OCTOBER 27<sup>th</sup>, 2021 MINUTES [NO CLOSED SESSION CONTENT]

#### **CALL TO ORDER:**

Councilman Fred Fox called the meeting to order at 12:51 PM.

#### **ROLL CALL:**

**Present:** Councilwoman Monica Mayer, Councilman Cory Spotted Bear & Councilman Fred Fox. *Quorum established*.

#### I. APPROVAL OF AGENDA:

Motion: Councilman Fred Fox moved to approve the agenda. Councilwoman Monica Mayer seconded the motion. Vote: 3-0-0. Motion carried.

## II. APPROVAL OF MINUTES:

## III. NEW BUSINESS:

## A. KLJ ND Highway 73 Project

Project goals for safety improvements, Wider Shoulders, Flattened Inslopes, Improved curve geometry, Climbing lanes and a Roundabout at ND 22. Will work on Pavement improvements and Structure Replacements. The right of way process, Follows Tribal & BIA process, Federal Uniform Act, Need is determined both permanent and temporary, Environmental Clearance is obtained & ROW is authorized, Need is communicated with land owners, Land ownership is determined, plats and valuations are developed and purchase offers and negotiations with land owners. Next steps & Schedule, Finalize Plans & Specifications Winter 2021, ROW Winter 2021/2022 and Construction (Pending ROW Acquisition) 2022.

# B. ND Highway 23 Safety Project - Roger White Owl, North Segment

Working on getting a turning lane by the cultural center. Want to put in some more turning lanes by the lagoon. DOT will stretch out the road. Need signing for ROW's. Roger thinks it should be 45 by BIA 2. Need tribal support for easements

#### C. Mandaree Orchard Project – Elton Spotted Horse

Tabled for Representative Review.

#### D. Deann Birdsbill Road Repair

Deann has a homesite in Four Bears segment. Her road needs to be maintained, the school bus will not drive on the road. Councilwoman V. Judy Brugh recommends to have an oil company

## H. Fort Berthold Rural Water (FBRW)

ROW Resolution entitled. "Consent to Certain Right(s) of Way across Tribal land". West Segment for rural water project in Mandaree.

*Motion:* Councilwoman Monica Mayer moved to forward resolution to TBC. Councilman Fred Fox seconded the motion. Vote: 3-0-0. Motion carried.

Councilman Fred Fox asked about the White Shield water tower. FBRW needs more funding and needs to bring in a cost estimate.
