CALL TO ORDER:

Councilwoman Monica Mayer called the meeting to order at 10:30 AM.

A. Medical Request - Delphine Baker

She is a legal guardian for sister Carolyn Danks. She is in Good Shepard Nursing home. Delphine has been her legal guardian since 2008. The last 3 years turned her disbursements over to the Nursing home because she is on Medicaid. Delphine has been trying to set up a burial plan for her. They denied her Medicaid. Delphine too her shopping with some of the money, but the nursing home owns that money. They are mailing back the \$2,500 and \$1,000 checks back because it will kick her off Medicaid. Delphine is asking what to do. Councilwoman Monica Mayer states, there have been other tribal members that this happened to. Medicaid is the best payer, and they are trying to remove her because she gets disbursements. This is her only income, the State is using the disbursements to take her off Medicaid. \$7,000 annually as an excuse to kick her off Medicaid. Councilwoman Monica Mayer recommends to forward to TBC and have the Chairman write a letter to the County and Medicaid.

Motion: Councilman Cory Spotted Bear moved to forward to TBC for further discussion. Councilman Fred Fox seconded the motion. Vote: 3-0-0. Motion carried.

B. M.B. Hearing Aid Payment - Councilwoman Sherry Turner-Lone Fight Seeking assistance to pay a past due bill for the purchase of hearing aids. Bill was previously referred to I.H.S. & the Elder's Program denied her application due to the bill being too old.

A. Elbowoods Memorial Health Center (EMHC) - Kathryn R. Eagle-Williams, MD MPH, CEO

Report submitted for the record. Dr. Martin gave the monthly report. No action items. Councilman Cory Spotted Bear asked to be included in the vaccination in Twin Buttes since there isn't a provider currently there. Dr. Martin states they are doing so this month. Would like to do vaccines on Wednesday here at the Tribal Building, Northern Lights does vaccinations and testing every Wednesday. Provided a COVID-19 Information Report. CDC and FDA have approved booster doses for the 3 vaccines used in the United States: Pfizer, Moderna, and Jensen (Johnson & Johnson) Continue to recommend isolation for 10 days following testing positive to COVID-19. Not recommending the new CDC 5-day isolation policy. Information provided on the Delta & Omicron Variant from the CDC along with vaccination updates. Councilwoman Monica Mayer would like to do an Omicron package and wants to add a home Covid test, even if it's just for the elders. It was noted that Report on Covid testing. Total tests done: 22,187 with a total 1,337 positive for a positivity rate of 6.0%. Current hospitalized: 1 (all unvaccinated). Total hospitalized from July 2021 to present: 22. Current active cases: 24. Deaths: 25. Fully vaccinated: 19.8% (107 positive cases out of 539 total positive cases since Aug. 1,2021).

They should be compensated for that time. Elizabeth states it's just her position as the Director, everyone else gets the Holiday hours and the overtime. If she cannot get those could she be switched to Exempt so she could get Admin leave? They did get approved for Federal Holiday pay and overtime, the past director didn't get that which Elizabeth is not qualified for. Councilwoman Monica Mayer asked the Committee if they should forward to TBC, because she should be exempt.
