B. Request for Resolution for Research - Dr. Andrew Curley

The proposed research will analyze energy transition in native communities. We will conduct semi-structured focus groups within the MHA community to gather data on how native community members experience and understand energy in their communities. We are currently booking space within the community to host these focus groups. By talking to tribal community member, we will understand how they understand energy use and production, their attitudes towards current energy production and transition, and what solutions and limitations they see with the energy production. Our focus groups will consist of twelve community members and we will have three sessions. We are hoping to get at least thirty-six community members. We will be posting flyers to recruit members and seek others from the participants who initially participate. We will be seeking community members who are eighteen and older. Participants will receive a gift card even if they decide to withdraw earlier. We will issue consent forms and let the participants know about they study before they agree to participate. We will keep potential subject's information confidential. As for data gathering and storage, we will also reserve rooms where we can talk without people overhearing or without interruption for the focus groups. We will remove names from transcripts and assign participants numbers. We will create a "key" to the study that lists participants with

identifying information that we will store on an external hard drive kept in Dr. Curley's locked office. In analysis, we will use pseudonyms and protect against descriptions that might lead to deductive disclosure. Because the communities are small, the potential for deductive disclosure is the greatest risk for informants. To prevent this, we will remove identifying characteristics or create composite informants, an informant made up of different responses from different people who serves as an ideal type.


