XXI. JUDICIAL COMMITTEE — Councilwoman V. Judy Brugh, Chair

A. Tribal Court Report* - Elizabeth Yellow Bird & David Christenson, Chief Judge Report submitted for the record. The Well ness Court continues as a priority; the Wellness Court has been officially operating for one year in April 2022. The Wellness Court staffing meets every Thursday to provide support, hearing details of participants progress, and, admit any new participants. The Wellness Court Steering Committee meets once per month to provide advice and counsel to the Well ness



Court. A report is submitted each month providing you statistics and information regarding the Wellness Court. A grant was written and submitted in April for a Tribal Youth Wellness Court, the purpose of the grant is to support creation of a youth treatment center on Fort Berthold, to support addition of more staff in the Juvenile Department, and to provide cultural information and academic support, and more assistance for our youth. The Court continues to address COVID 19, and is following the T AT protocol as updated regarding vaccinated and unvaccinated staff. Regular cleaning and sanitizing the facility and practicing social distancing continues with the Court. The Court plans on utilizing "imaging" application through FullCourt and should have all the files digitized within the next year. This will be a separate training that the Justice Systems has not scheduled yet. We also are finalizing a telephone messaging, alert system and intercom call systems. The Court continues to work on our own Policies and Procedures Manual, A draft has been completed and was sent to the Justice Commission for review and approval. The Justice Commission met on March 11th but was not able to discuss the policy manual. The next Justice commission meeting will be held on Thursday May 26th. The focus of the next meeting will be the role and responsibility of the Justice Commission; we will be working off of a September 2021 updated draft or work previously completed. We continue to work on updating forms the court uses in the manual and on our website. The Court is working on adding an educational component, maybe a newsletter, to our website with more specific information about the Court and its processes. We have a small work group who are working on the educational component and have set the end of May to have a working product. The Court continues to work on holding court in some of the segments. One of our Judges is working on setting them up and doing brochures and educational materials to hand out. We will need to make sure that the Court areas are safe and secure for the court sessions. Meetings have been held regarding the Tribal Codes; Sharon Thompson, Tyra Wilkinson, Judges Christensen and Seaworth and the Court Administrator have been in attendance. Title 1 has been completed and Sharon Thompson's office is working on reformatting and setting up another meeting. The Court was fortunate to have a law clerk working temporarily. He worked previously for the Court, and will be graduating from Law School in May and hopefully will be a Court staff member after completing the bar. The Prosecutors office remains very busy as they continue to learn processes and procedures and how they can assist the community the best way possible. The prosecutor's office submits the Criminal Department report in the monthly reports. The Court has been meeting with XTIRI staff to provide information and training on the XTIRI application which is a data management software. Good Road Recovery Center, Traci Burr did a presentation regarding the disease of addiction. Nine staff members completed and are certified as Alcohol and Drug testers; this is a 5-year certification. The Court completed one jury trial and is anticipating a few more in the coming months. Because of the weather and electrical issues, and as

per directive, the Court was closed. According to the Policy Manual the Court was not considered essential staff. However, we understand that there will be a request to list the Court as essential staff.
