Councilman Fred Fox called the meeting to order at 1:12 PM.

ROLL CALL:

Present: Councilwoman Sherry Turner Lone-Fight. Councilman Fred Fox & Councilman Cory Spotted Bear *Quorum established.*

I. <u>APPROVAL OF AGENDA</u>

Motion: Councilman Fred Fox moved to approve the agenda. Councilwoman Sherry Turner-Lone Fight seconded the motion. Vote: 3-0-0. Motion carried.

II. APPROVAL OF MINUTES

• April 26th 2022 Natural Resources Committee Minutes.

Motion: Councilman Fred Fox moved to approve the April 26th 2022 Natural Resources Committee meeting minutes subject to minor corrections. Councilwoman Sherry Turner-Lone Fight seconded the motion. Vote: 3-0-0. Motion carried.

III. <u>NEW BUSINESS</u>

A. ND High Way 73 Project - Austin Hill, KLJ

Mark Anderson presented. The committee was shown a power point that KLJ had that explained the upcoming project on Highway 73. Project goals are wider shoulders, flattened in the slopes, improved curve geometry, climbing lanes, roundabout at Hwy. 73 & ND 22. Pavement improvements, & Structure Replacements. Ray Barchinger, a plan and design are done, now a ROW is needed. From FBIR to off the reservation on Hwy. 73. There are 5 allotments and trust, waiting to have a meeting regarding this. One section is privately owned and does not real affect the project. This project will begin the summer of 2022. The NDOT has sent out notifications of the project to the allottee and they have only received on response back so far. They are attempting to meet with the allottee, there is around 70 of them.

B. 2022 TAT Cemetery Code - Lane Standish

Ed Hall created a Cemetery Code and Lane presented it today for the first reading. Has been reviewed by Legal.

FTR: Councilwoman Monica Mayer joined the meeting at 1:35 PM.

Spread thin to work on all the cemetery work. There are 21 cemeteries from Twin Buttes to New Town. There were about 1,700 graves moved from Elbowoods. Councilman Cory Spotted Bear inquired about fencing, and informed the presenter that a couple cemetery's in Twin Buttes still need fencing. FF asked Mr. Standish to meet with Austin Gillette about work that needs to be done at the Old Scout Cemetery in White Shield. They are currently getting markers for them. Next week have foot stones for Queen of Peace cemetery to install. Want to replace all the



footstones with the \$120,000 budget for this year to work on these. Work with the Corps of Engineers who is going to pay half the cost. BJ Brady informed Lane there are unmarked graves by Pouch Point.

Motion: Councilman Fred Fox forward the 1st reading of the Cemetery Code to TBC. Seconded the motion. Councilwoman Sherry Turner-Lone Fight seconded the motion. Vote: 4-0-0. Motion carried.

E. Elk Pasture Lease South Segment

Jody Ground presented Elk Pasture leases for the South Segment Elk Project that have Legal review. Looking for a land swap in Phase I for the 500-acre pasture in allotments: 981A, 1116, 1130, 1133 & 3095.

G. Bernie Fox Land Issue

His dad Angus Fox had land in Mandaree that was exchanged and approved by the tribe by resolution 04-049-RP back in 2004. When years later he was using land that didn't get recorded. 5 years ago, they found out from BIA Superintendent Kayla Danks BIA the land in question is still registered as the tribes land. the road project started in Mandaree, they came through and scraped the top of the land off. About 3 weeks ago, his niece texted Bernie that she wanted to put a home on the land. His dad wanted his five children to have land by each other. One of Mr. Fox's relatives wants to put a home site in Mandaree area which is in the middle of Angus Fox's land which still shows as tribal land. This issue has caused a feud with relatives.

The gross negligence of the BIA by not doing the land exchange from 16 years ago. Why can't we have an advocate to work with the BIA to make sure these things get done. Texx Lone Bear recommends Legal review for this land exchange. Councilman Fred Fox recommended Texx Lone Bear get a list of land exchanges and sit with the BIA and see if they were finished. Councilwoman Monica Mayer stated that we need our own Reality Agent to work with BIA.

2) Native American Nationals Premier Indigenous Series II - Nathanial Preston Smith The sponsorship would aid us in our team's first traveling basketball tourney in Mesa, Arizona, Native American Nationals Premier Indigenous Series II, with our youth 9th /10th grade boys on June 24th-26th 2022. The travel dates start on June 22nd, 2022, as the coach's meeting for teams is on June 23rd, so the duration of the trip will be June 22nd_261h• We plan to stay in an Airbnb down in Mesa, Arizona, with the whole team, and all for costs and travel are available on a spreadsheet. Moreover, staying with the whole team is better than a hotel stay because it generates cohesion and team building. Additionally, our young athletes also have a food fundraiser before we leave in June. The support from our MHA Nation would help and invest in our young native athletes who are excited and proud of the opportunities that they get to experience in their sportsmanship.
