Report submitted for the record. Three open positions; Collections, Data Entry Clerk, Receptionist & File Clerk. March Revenues: \$238,760.60. Working on list for August Disbursement list. Working on list for Councilman Mayer requested data on delinquent loans. Marietta Heart continues to do reconciliations and receivables. Andrea Brown continues to work on reconciliation's and helping out with clients. Sue Romero continues to work with clients, reviewing and entering in loans.

E. TAT Mortgage Program - Valerie Mayer, Director

Report submitted for the record. Due to covid restrictions all travel limited still. No upcoming planned. We have started the training process for our new software program to provide loan servicing with data management for all our loan programs. Each loan program will have its unique loan profile set up according to their lending policies and their loan limits, terms and needs. This is on-going set up and training. We continue to enter data in practice mode until we are entirely ready to go Live. This will be a transition from our previous software, Loan Ledger that was abruptly discontinued. We are waiting for training to resume with the loans department. Last Mortgage Loan Committee meeting held 02/08/22 with 3 new home loan approvals and 3 existing loan clients for additional. Total approved \$628,400.00. Next meeting anticipated for month of August 2022. Date confirmation pending confirmation. We are working toward the implementation of our new mortgage software and training for staff to rebuild accounts up to date post data/software interruption earlier this year, April 2021.-Continuous. Update on new software: We are scheduled for the new software implementation and training of staff October 2021. We were advised they will be training all loan staff starting with Small Loans, Mortgage Loans, then Business Loans. This is still in progress with trainer. -Continuous. To work towards improving monthly collection accounts with both collection activity and or further legal review for recommendations. This is and will be a continuous effort in program. Each year we continue to strive to increase our totals on all accounts. Collection procedures are a work in progress and continue to be enhanced to result in consistent ending year totals. (see attached totals report) Staff continues to work on loan management daily and working with communicating with borrowers. Each new application has a review process for qualifying borrower for long term mortgage loan. Review and verifying information data provided is a process for each applicant. With each loan account approved various factors and or demographics apply to each applicant's home project which can affect each loan process all together. This includes the monitoring and communicating of property insurance, property taxes as they can change annually. Staff continue to ensure
