Three serious findings from the Head Start audit. One of the findings includes audit submission. Have 120 days to address or will lose the funding of \$3.5 million. Currently \$700,000 tribally funded. 2019 TAT Audit is projected completion in October with the following years being completed in a more rapid succession due to 2019 being a year that the tribe migrated to the new financial system . CEO has visited with funding agency to address other issues. Chairman Mark N. Fox noted some will not be able to apply for funding. CEO will work with the Headstart Director to stay abreast of the situation.
